## WHITEHALL.

The following being the last Act of Parliament relating to the horrid Crime of Murder, is here inserted for the Information of the Publick.

An AEt for better preventing the horrid Crime of MURDER.

HEREAS the horrid Crime of Murder has of late been more frequently perpetrated than formerly, and particularly in and near the Metropolis of this Kingdom, contrary to the known Humanity and natural Genius of the British Nation: And whereas it is thereby become necessary, that some further Terror and peculiar Mark of Infamy be added to the Punilhment of Death, now by Law inflicted on such as shall be guilty of the said heinous Offence; May it please your most Excellent Majesty, that it may be enacted, and be it enacted by the King's most Excellent Majesty, by and with the Advice and Consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the Authority of the same, That from and after the First Day of Easter Term, in the Year of our Lord One thousand seven hundred and fifty two, all Persons who shall be found guilty of wilful Murder, be executed according to Law, on the Day next but one after Sentence passed, unless the same shall happen to be the Lord's Day, commonly called Sunday, and in that Case on the Monday following.

And be it further enacted by the Authority aforesaid, That the Body of such Murderer so convicted, shall, if such Conviction and Execution shall be in the County of Middlesex, or within the City of London, or the Liberties thereof, be immediately conveyed by the Sheriff or Sheriffs, his or their Deputy or Deputies, and his or their Officers, to the Hall of the Surgeons Company, or fuch other Place as the faid Company shall appoint for this Purpose, and be delivered to fuch Person as the said Company shall depute or appoint, who shall give to the Sheriff or Sheriffs, his or their Deputy or Deputies, a Receipt for the same; and the Body so delivered to the said Company of Surgeons, shall be diffected and anatomized by the faid Surgeons, or such Person as they shall appoint for that Purpose: And in case such Conviction and Execution shall happen to be in any other County, or other Place in Great Britain, then the Judge of Justice of Assize, or other proper Judge, shall award the Sentence to be put in Execution the next Day but one after such Conviction (except as is before excepted) and the Body of such Murderer shall in like Manner be delivered by the Sheriff, or his Deputy, and his Officers, to Such Surgeon as such Judge or Justice shall direct for the Purpose aforesaid.

And be it further enacted by the Authority Aforesaid, That Sentence shall be pronounced in open Court immediately after the Conviction of

fuch Murderer, and before the Court shall proceed to any other Business, unless the Court shall see reasonable Cause for postponing the same; in which Sentence shall be expressed not only the usual Judgment of Death, but also the Time appointed hereby for the Execution thereof, and the Marks of Infamy hereby directed for fuch Offenders, in order to impress a just Horror in the Mind of the Offender, and on the Minds of fuch as shall be present, of the heinous Crime of Murder.

Provided always, and be it enacted, That after such Sentence pronounced as aforesaid, in case there shall appear reasonable Cause, it shall and may be lawful to and for fuch Judge or Justice, before whom such Criminal shall have been so tried, to stay the Execution of the Sentence, at the Discretion of such Judge or Justice, Regard being always had to the true Intent and

Purpose of this Act.

Provided also, That it shall be in the Power of any such Judge or Justice to appoint the Body of any fuch Criminal to be hung in Chains: But that in no Case whatsoever the Body of any Murderer shall be suffered to be buried; unless after such Body shall have been dissected and anatomized as aforesaid; and every such Judge or Justice shall, and is hereby required to direct the same either to be disposed of as aforesaid, to be anatomized, or to be hung in Chains, in the same Manner as is now practised for the most atrocious Offences.

And be it further enacted by the Authority aforesaid, That from and after such Conviction; and Judgment given thereupon, the Goaler or Keeper, to whom such Criminal shall be delivered for safe Custody, shall confine such Prisoner to some Cell, or other proper and safe Place within the Prison, separate and apart from the other Prisoners; and that no Person or Perfons whatfoever, except the Goaler or Keeper, or his Servants, shall have Access to any such Prisoner, without Licence being first obtained for that Purpose, under the Hand of such Judge or Justice, before whom such Offender shall have been tried, or under the Hand of the Sheriff, his Deputy, or Under Sheriff.

Provided always, That in case any such Judge or Justice shall see Cause to respite the Execution of such Offender, so condemned as aforesaid, such Judge or Justice may relax or release any or all of the Restraints or Regulations herein before or herein after directed to be observed by the Goaler or Keeper of the Prison, where fuch Prisoner shall be confined, by any Licence in Writing, signed by such Judge or Justice for that Purpose, for and during the Time of such Stay of Execution; any Thing herein before contained to the contrary thereof notwithstanding.

And be it further enacted by the Authority aforesaid, That after Sentence passed as aforefaid, and until the Execution thereof, such Offender shall be fed with Bread and Water only, and with no other Food or Liquor whatsoever (except in case of receiving the Sacrament of the



Lord's

Lord's Supper, and except in case of any violent Sickness or Wound, in which Case some known Physician, Surgeon, or Apothecary, may be admitted by the Goaler or Keeper of the said Prison to administer Necessaries; the Christian and Surname of fuch Physician, Surgeon, or Apothecary, and his Place of Abode, being first entered in the Books of such Prison or Goal, there to remain) and in case such Goaler or Prison Keeper shall offend against, or neglect to put in Execution, any of the Directions or Regulations hereby enacted to be observed, such Goaler or Prison Keeper shall, for such Offence, forfeit his Office, and shall be fined in the Sum of Twenty Pounds, and suffer Imprisonment. until the same be paid.

And be it enacted by the Authority aforesaid, That if any Person or Persons whatsoever shall by Force set at Liberty, or rescue, or attempt to rescue or set at Liberty, any Person out of Prison, who shall be committed for, or sound guilty of Murder, or rescue, or attempt to rescue, any Person convicted of Murder going to Execution, or during Execution, every Person so offending, shall be deemed, taken, and adjudged to be guilty of Felony, and shall suffer

Death without Benefit of Clergy.

And be it further enacted by the Authority aforesaid, That if any Person or Persons whatsoever shall, after such Execution had, by Force refcue, or attempt to rescue, the Body of such Offender out of the Custody of the Sheriff, or his Officers, during the Conveyance of such Body to any of the Places, hereby directed, or shall, by Force, rescue, or attempt to rescue, fuch Body from the Company of Surgeons, or their Officers or Servants, or from the House of any Surgeon, where the same shall have been deposited in pursuance of this Act; every Person so offending, shall be deemed and adjudged to be guilty of Felony, and shall be liable to be transported to some of his Majesty's Colonies or Plantations in America, for the Term of Seven Years, in like Manner as is directed by the Laws now in Force relating to the Transportation of Felons; and shall be subject to the like Punishment, and Methods of Conviction, in case of returning into, or being found at large within Great Britain, within the said Term of Seven Years, in all Respects, as by Law other Felons are subject to, in case of unlawfully returning from Transportation.

Provided always, and it is hereby enacted by the Authority aforesaid. That nothing herein contained shall extend to repeal or alter so much of an Act made in the Eleventh Year of his late Majesty's Reign, (intituled, An Act for the more effectual disarming the Highlands in that Part of Great Britain called Scotland; and for the better securing the Peace and Quiet of that Part of the Kingdom, as relates to the Suspension of the Execution of Persons convicted of capital Offences, within that Part of Great Britain talled Scotland) for the respective Times in the said Act mentioned; any Thing herein before contained to the contrary notwithstanding.

Whitehall, April 25.

By Letters received this Morning, dated the 17th Instant, there is an Account, that his Majesty arrived at Hanover on Friday the 10th Instant, about Four o'Clock in the Asternoon, in perfect Health; and that his Grace the Duke of Newcastle was expected to arrive there on Sanday last.

Warsaw, April 14. Preparations are now actually making at Grodno, in the Grand Dutchy of Lithuania, for the King's Reception, who intends going thither in the Month of October next, in order to affist at the general Diet of the Kingdom, which 'tis hoped will prove more successful than the last. According to Advices from the Frontier Provinces bordering upon Russia, the Officers belonging to the Russian Troops stationed on those Frontiers have caused such a Number of small Forts to be erected along the Dnieper, as have entirely prevented any late Incursions of the Heyducks, who for a long Time before were almost continually plundering the Inhabitants, and disturbing the Tranquility of those Provinces. We are informed by Letters received here the last Post from Brezlowie, that on the 7th Instant a Fire broke out in that Town, which burnt with such Violence, that the whole Town was almost reduced to Ashes, notwithstanding the Inhabitants of the neighbouring Villages gave them all the Assistance in their Power; by which fatal Accident the poor People were in the utmost Distress, not having been able to save but a small Part of their Effects.

Vienna, April 15. The Departure of the Court for Schonbrun is fixed for Monday next, for which Purpose the Emperor, who has been for some Days taking the Diversion of Hunting at the Seat of Count Palfy, is expected here this Evening. Her Imperial Majesty has dispatched an Express to Count Pallavicini, Governor of the Dutchy of Milan, to cause all the fortified Places in Lombardy to be repaired this Summer, and to see that the Magazines and Arsenals in that Country be completely filled. We are informed by Letters received here from our Conful at Algiers, that, agreeable to his Instructions, he has released all the German Slaves, amounting to Twenty, and provided them with Necessaries for their Passage Home.

Copenhagen, April 18. The King set out on. Wednesday last for Friedensbourg, where his Majesty proposes to pass the greatest Part of the Summer. The Disputes which have subsisted for a long Time between this Court and that of Sweden, on Account of certain Districts in Norway, are at length adjusted to the mutual Satisfaction of the two Courts; and 'tis said the Treaty concluded on this Occasion will soon be

published.

Gopenhagen, April 25. The Queen Dowager sets out next Week for Hirscholm. His Danish Majesty has been pleased, by a new Regulation dated the 14th Instant, to shorten the usual Time of private Mournings, to six Months. M. de Marteville, Envoy from the States General to the Court of Sweden, is just arrived here on his Way to Stockholm.

Berlin, April 21. The King has appointed the Sieur Kroll to be Director of the new Mint, and he has accordingly taken Possession of that Employment. The Marriage of Prince Henry, the King's Second Brother, with the Princess Guillelmine, Daughter of the Prince of Hesse Cassel, will certainly be celebrated in a short Time. Prince Louis of Wirtembourg set out from hence Yesterday for Treptow in Pomerania, in order to take Leave of his Brother Prince Eugene, being on his Return to France.

Munster, April 23. A few Days ago several Persons were seized at Dettmold, in the County of Lippe, and brought Prisoners to this City. They have lately committed a great Number

of

of Robberies and Murders in this Neighbourhood; and by their Examination it appears, that they belonged to a Gang that was first formed in Silelia, who afterwards spread themselves over

great Part of the Empire.

Dresden, April 23. Count Keyserling, whom the Czarina has appointed her Minister to the Court of Vienna, had, on Friday Morning last, his Audience of Leave of the King of Poland; and M. Gross, who is appointed his Successor here, presented his Credential Letters. The King and Queen of Poland fet out Yesterday Evening for Leipsick Fair,

Dusseldorp, April 24. Prince Frederick of Deux-Ponts is shortly expected here to review the Palatin Troops. A few Days ago the Elector our Sovereign caused an Ordonnance to be published, by which the Pardon of fix Months that was granted to all Deserters from our Troops, is prolonged to the first Day of No-

vember next.
