Leghorn, Marth 10.

HE last Letters we received here from Corsica say, that the Malecontents have had several Meetings to consider of proper Measures for opposing the Genoese, after the French Troops have abandoned that Island, but that nothing has as yet been agreed on. The same Letters add, that the French Troops lay quiet in their Cantonments, and only waited for the Transports, in order to embark for Provence.

Florence, March 13. The new Farmers of the Revenue of this Grand Dutchy, have agreed for Leases of the same for nine Years, to commence the first of January next. Count Richecourt, President of the Council of our Regency, is shortly expected here from Vienna, when several new Regulations will be made for the Improvement of our Finances and Commerce.

Turin, March 15. They write from Parma, that the Infant Duke has appointed M. Astier to be Intendant of his Finances, in the room of Count Carraccioli, lately dismissed from that

Employment.

Estockholm, March 19. An Ordonnance is published here, appointing the 4th of May, the ist and 29th of June, and the 24th of September, to be observed as publick Fast Days throughout this Kingdom. They continue to assure us, that the King intends to take a Journey this Year into Scania, and some other Provinces which he has not visited fince his coming to the Throne. His Majesty has ordered the Regiment of Hamilton, and those quartered in Swedish Pomerania, and in the Island of Rugen, to be augmented with ten Men each Company, and they have already began to raise Recruits for that Purpose. 'Tis confidently reported, that the Queen is again with Child, and that the same will soon be declared at Court. The Gold Mines discovered some Time since in the Island of Smaland, continue to be worked with great Success, and they are now actually coining at the Mint a large Quantity of Ducats of Gold extracted from Ore taken out of the faid Mines.

i Copenhagen, March 26. They are continuing to, make Preparations for the Camp intended to be formed in the Neighbourhood of Rotschild. Upon a Representation made to the King in Relation to the Prohibition of wearing Jewels of all Kinds, his Majesty has thought proper to make some Variation in the Ordonnance published on that Occasion, whereby all artificial Stones made up in this King-

dom, are permitted to be worn. The King has ordered, that for the Future the Ingineers belonging to the Fortifications, shall have Liberty to serve in his Majesty's Armies; and that Majors and Captains of the Artillery shall rank with Majors and Captains of the Guards.

Dresden, March 26. On Monday last was celebrated at Court, with great Magnificence, the Feast of St. Joseph, whose Name the Queen and Madame la Dauphine bear; on which Occasion their Majesties received the Compliments of the Nobility, Foreign Ministers, and other Persons of Distinction: After which they dined in Publick with the Princes and Princesses of the Royal Family; and the Evening concluded with the Firing of Cannon, and other Marks of publick Rejoycing.

Berlin, March 26. The King has ordered a a spacious Edifice to be erected in this City for the Manufacturing of Silk, under the Direction of M. Schutzen, one of the Directors of the Embden Company. To-morrow the Birthday of the Queen-Mother will be celebrated as usual, for which Purpose they are now making the necessary Preparations. The two young Princes Corsini, who arrived here a few Days ago from Dresden, are treated at Court with

great Marks of Distinction.

Hambourg, March 29. We are informed by our last Letters from Stockholm, that Orders have been given for all the Troops in that Kingdom to hold themselves in Readiness to pass in Review during the Course of the Month of May next. They write from Moscow, that the Empress of Russia is quite recovered of her late Indisposition, and assists regularly at her Councils. The same Advices add, that the Vice Chancellor Count Woronzoff, who was so ill for several Days, that his Life was despaired of, is now so well recovered, as to be able to do Business.

Utrecht, March 30. Last Wednesday was strictly observed here as a general Fast, on which Occasion upwards of three Thousand and forty

Florins were collected for the Poor.

Brussels, March 31. The Cardinal of Bavaria, Prince and Bishop of Liege, arrived here on Tuesday last in the Evening, attended by Count Horion, Grand Master of his Houshold, Count Breidenbach, Great Chancellor, and Count Sedlnitzky, his Master of the Horse; he was saluted at his Entrance into this City by a general Discharge of the Cannon upon our Ramparts, and was received with great Marks of Distinction by Prince Charles of Lorrain, who immediately conducted him to an Apartment prepared for his Reception in the Palace.

To Make the

Lithontriptic Mais and Electary. AKE Five Pounds-of Alicant Soap, shaved, and One Pound of Oystershell Lime; put them into a Tin Vessel, and pour upon them Five Quarts of Water: Make the Water boil till the Soap be perfectly diffolved in it, and then strain all into a glazed earthen Vessel. Expose this Mass to the Air, stirring it every Day till it becomes both mild to the Taste, and of a proper Confistence to be formed into Pills : or long Pellets, without sticking to the Fingers. This may be expected to happen in Two or Three Months. If it becomes sufficiently mild before it has acquired a due Consistence, it may be brought to this by being heated over a Fire, in a Tin Vessel: If it acquires too hard a Confistence, before it be sufficients ly mild, it must be sosten'd with Water. The Mass here described is what I call the Lithontriptic Mass. I direct a Tin Vessel, because a Brass or Copper One would make it Emetic.

It may be prepared in a more expeditious Mamer, as follows; (but, where Time can be allow'd for it, I prefer the foregoing) Pour Two Gallons of Water upon a Pound of Oystershell Lime, stir it two or three Times, and when it has fallen to the Bottom, pour off the clear Part of the Water. Repeat this fisteen or twenty Times, or till the clear Water, which is poured off, be almost tasteless, leaving about Five Pints of Water upon the Lime, after the last Ablution: Then pour this Mixture of Water and dulcified Lime upon Five Pounds of Alicant Soap, shaved, and proceed as above directed. The Mass thus prepared will be fit for Use in a few Days, or even immediately.

If the Mass of Soap and Oystershell Lime, dulcised in either of the above-mentioned Ways, be made of the Consistence of an Electary, I call it the Lithon-triptic Electary. This Form is more convenient than the Mass, for those who defire to take the Medicine dissolved in a liquid Vehicle: The most suitable ones are Milk, Water sweeten'd with Honey or Sugar, Water slavour'd with Wine, Brandy, or Run,

and Small-Beer.

Where a Person is supposed to have a large Stone in the Kidney or Bladder, he ought to take every Day as much of the Lithontriptic Mass, or Electary, as contains two Ounces of the Soap, unless his Pain and Provocation to make Water be violent; in which Case it will be proper to begin with about Half this Quantity, and to increase it as he can bean. The Medicine ought also, in this Case, to be duscised in an extraordinary Degree.

The Generation of Gravel and Gravel-Stones may be entirely prevented by this Medicine: It is like wife of great Service in Disorders of the Stomach and Bowels, arising from, or attended with Acidities there, and in gouty Habits. The Patient may, in any of these Cases, begin with such a Quantity every Day, as contains an Ounce of Soap, and afterwards increase or lessen his Quantity as he finds Occasion.
