Lisbon, April 24.

SOME considerable Seizures of Gold Coin has been lately made by our Custom-house Officers, on Board of Vessels that were carrying it, in a clandestine Manner, out of the Kingdom. The late great Drought, which held for six Months together, having been succeeded by fine soft Rains, a solemn Procession was made, on the 15th Instant, to return Thanks to Almighty God for the same. On Monday last, the Count de Parade the new Spanish Ambassador, arrived here with a numerous Retinue; and Yesterday he had his first private Audience of the King, Queen, and all the Royal Family. The two Men of War, lately launched in this Port, are getting ready, with all Expedition, to convoy, in Conjunction with the St. Joseph, another Man of War, the Fleet bound for Maranham, which is to put to Sea on the 15th of next Month. 'Tis strongly reported here, that the Notre Dame de l'Esperance, which sailed from hence some Time since for Buenos-Ayres, is cast away on her Voyage, and very little of her Cargo saved.

Petersbourg, May 4. On Wednesday last, being the Great Princess's Birth-day, who then entered into the 25th Year of her Age, the same was celebrated, in a very elegant Manner, by Admiral Prince Galliczin, who gave a most expensive Dinner to all the principal Nobility and Gentry on that Occasion. At Night there was a triple Discharge of the Cannon, and Bonfires and Illuminations throughout the City. We hear from Moscow, that on the 25th past an Express arrived there from M. Obreskow, our Resident at Constantinople, which occasioned a long Conference to be held at the Great Chancellor Count Bestucheff's, at the Breaking up of which, a Courier was dispatched to Vienna.

Naples, May 7. Advice is received at Court, that a Barbary Pink, carrying 14 Pieces of Cannon, and 140 Men, is taken by our Chebècks in the Seas of Sicily.

Rome, May 9. The Congregation of Rites are preparing for the Beatification of the cele-

brated Cardinal Bellarmine. Last Monday the Duke and Dutches of Wirtembourg set out from hence on their Return home. There are upwards of 400 Workmen employed in Repairing the Post of Anzio, which 'tis thought will be completed this Summer.

Turin, May 12. By our last Letters from Corsica, the Affairs of that Island seem greatly embarrassed; the Malecontents, and indeed most of the Inhabitants, shewing the utmost Unwillingness to live quietly under the Government of the Genoese.

Dantzick, May 14. The many false and scandalous Reports and Insinuations that have of late so artfully been spread Abroad, as if this City was always in Confusion by Disputes and Dissentions amongst the Magistrates and Burghers, and that too at a Time when the greatest Harmony subsists between them, and the City itself is in a flourishing Condition, has occasioned the Magistrates, in Conjunction with all the Orders, to cause an Ordonnance to be published, wherein they entirely confute all such malicious Reports and Insinuations, and offer a Reward of One Thousand Crowns for the Discovery of the Author or Authors thereof.

Warsaw, May 15. We learn by our last Advices from the Frontiers of Poland, that the Turks are actually making such Dispositions as give great Room to believe they intend shortly to assemble a considerable Body of Troops on the Side of Little Tartary.

Stockholm, May 15. On Saturday last their Majesties set out from hence for Ulrichsdall. The King has given Orders for the Troops in the Provinces of Smaland and Gothland, to hold themselves in Readiness to pass in Review before his Majesty. The Queen advances happily in her Pregnancy, for whose safe Delivery publick Prayers are already put up in all the Churches of this City.

Modena, May 15. The Corps of our late young Hereditary Prince, after laying three Days in State in the Hall of the Ducal Palace, was interred with great Funerall Pomp in the Church belonging to the Capuchins in this City.

City. The Articles of the new Treaty of Commerce between the Duke our Sovereign, and the King of Sardinia, will shortly be made publick, and 'tis said are greatly to the Advantage of each other's Subjects.

Prague, May 16. The Troops appointed to form a Camp here this Summer, are ordered to assemble by the first of August, and are to remain in Camp till the Beginning of September. The Regiments of Foot ordered for this Service are those of Francis of Lorraine, Henry Daun, Saxe-Hildbourghausen, Old and Young Wolfembuttel, Wallis, Leopold-Daun, Esterhasi, and that of the Teutonick Order; the Regiments of Dragoons of Wirtembourg and Kollowrath; and that of Cuirassiers of Pretlack. When the Camp breaks up, the three last Regiments are to march from hence for Hungary, and are to be replated by those of Archduke Joseph, Batthiany, and Hohehembis.

Prentzlow, May 18. Last Week a severe Frost set in for four or five Days together in this Country, by which our Fruits, and particularly the Mulberries and Wallnuts, have suffered very much. The Hereditary Prince of Hesse Darmstadt, who proposed going to Berlin, in order to accompany his Majesty in his Tour to Prussia, has laid aside all Thoughts of that Journey, being determined to stay here till the Delivery of his Princess, which is now daily expected.

Vienna, May 19. On Tuesday last their Imperial Majesties came from Schonbrun to the Palace in this City, in order to give Audiences and sign Dispatches. The next Day the Empress Queen, the Archduke Joseph, the Archduchesses, and the Princess Charlotte of Lorraine, went to see a French Comedy acted by the Students of the College of Theresiens, who, when the Play was over, were all admitted to kiss her Hand. Her Imperial Majesty has appointed Count Korsensky to be First President of the Supreme Tribunal of Justice. The Weather has been so very frosty and cold in these Parts of late, that the Corn, Wines, and Fruits, are greatly damaged in all the Districts in this Neighbourhood.

Berlin, May 23. Last Sunday this Court went into Mourning for the Death of the late Prince Maximilian of Hesse-Cassel. The King has declared his Intention of setting out, on the 1st of next Month, for Prussia, in order to review his Troops quartered in that Country; in which Journey he is to be accompanied by the same Persons as went with him to Silesia.

Manheim, May 24. The Prince of Deux-Ponts is arrived here from Juliers and Burgues, having reviewed all the Palatine Troops quartered in those Dutchies. The Letters received this Post from Strasbourg, say nothing positive as to the Time the French propose to form their Camp this Summer in the Province of Alsace.

Paris, May 25. On Tuesday last an extraordinary Council was held at Marly, in the King's Presence, in which, 'tis said, a Resolu-

tion was taken to establish two new Commissions, the one for Criminal, and the other for Civil Affairs; that for Ecclesiastical Affairs has already begun its Conferences, and the Cardinal de la Rochefoucault, who was purposely sent for from his Archbishoprick of Bourges, assists thereat. 'Tis said the Grand Chamber of the Parliament held a general Assembly at Pontoise a few Days ago, in which it was unanimously agreed to abide by their Arrets of the 5th and 7th of this Month; which Arrets were the Cause of their Banishment. They write from Rouen, that the Parliament of that Place, in Imitation of that of Paris, has suspended its Functions; and we hear the Parliaments of Aix and Toulouse seem inclined to follow their Example. They write from Cadiz, that the Notre Dame du Rosaire, and another Ship belonging to the Havanna Company, arrived in that Bay the 30th past from Vera Cruz, both richly laden.

Hague, May 29. Last Thursday Night a solemn Deputation arrived here from the Province of Frizeland, and on Saturday the Deputies were admitted to a private Audience of her Royal Highness the Princess Governante. Her Royal Highness has made a considerable Promotion of Military Officers. This Morning the States of Holland and Westfrizeland, and the Deputies of the several Colleges of the Admiralty of these Provinces, renewed their Deliberations. On the 26th Instant the Regiment of Swiss Guards passed in Review before her Royal Highness the Princess Governante, and several General Officers, and made a fine Appearance. On Friday last died here William Maurice Count of Nassau, Lord of Ouwerkerke and Woudenberg, Field Marshal General of the Troops of this Republick, Governor of Dutch Flanders, and of all the Forts situate along the Scheld, Governor of Sluice, Colonel of a Regiment of Horse in this Service, and Member of the Body of Nobles of Holland and Westfrizeland; his Body is embalmed, and will be carried to Ouwerkerke, in order to be interred in the Tomb of his Ancestors.
