Lisbon, May 12.

DON Antonio Alvarez Da Cunha, Lord of Taboa, &c. embarked some Days ago, for his Government of the Kingdom of Angola.

Moscow, May 17. On the 14th Instant, about Four o'Clock in the Afternoon, a violent Fire broke out here, which destroyed upwards of 200 Houses, and would have occasioned a much more considerable Damage, if her Imperial Majesty, and their Imperial Highnesses the Grand Duke and Dutchess, had not given the most proper and careful Directions for the extinguishing of it: The Empress has been pleased, at the Intercession of his Britannick Majesty, to restore to her Favour the Counts Czernicheff and Leontioff, who had forfeited the same, by a Duel they fought some Time ago.

Leghorn, May 28. We here from Genoa, that the Duke and Dutchess of Wirtemberg, after having staid there two or three Days, had pursued their Journey for Turin, whence they were to proceed on their Return to their own Dominions.

Genoa, June 4. By Letters of the 26th past from Bastia, a Proclamation had been issued the Day before, by M. Grimaldi, the Republick's Commissary General, promising a General Pardon on Behalf of the Republick, to all the Inhabitants of the Island of Corsica, for all Offences committed to that Day; and exhorting the Inhabitants to apply to M. Grimaldi, that he may represent to the Republick, whatever may be desired by the People of the Island. The general Consultation of the Pieves, that was to have been held the last Day of May, has been postponed until the 8th Instant, from which Protraction it is judged, that the Chiefs of the Rebels are not inclined to put an End to the Rebellion by seeking Means of Accommodation, but rather to foment the Divisions, and keep up the Spirit of Animosity, to prevent a Reconciliation between the Republick and the Inhabitants of the Island, who seem to be rather favourably inclined. The Marquis St. George,

Prince of Ardore, who has resided several Years at Paris, as Ambassador Extraordinary from the King of the Two Sicilies, after a Stay here of four Days, set out for Parma on his Way to Naples.

Vienna, June 6. The Prince Jean Adam d'Aversperg's Consort, who was Countess of Shonfeld by her Birth, died here the Day before Yesterday, in the 25th Year of her Age. The Chevalier Mayo, who is to succeed the Prince of Campo-Reale as Minister from the King of the Two Sicilies at this Court, being expected here within the Course of next Week, Orders have been given to Count Firmian to keep himself in Readiness to set out for Naples.

Stockholm, June 7. Last Sunday the Court went into Mourning for six Weeks, on Account of the Death of Prince Maximilian of Hesse-Cassel. The King has lately granted the Title and Rank of Councillors for Trade, to the Directors of our East India Company.

Ratisbon, June 7. The Dutchess Dowager of Guastalla passed through this Town the Day before Yesterday, on her Way to Carlsbad, where she is to use the Bath of that Place.

Copenhagen, June 9. The Day before Yesterday, their Majesties went from Friedensburg to Fredricksburg, where they intend to reside some Time. The Queen's Pregnancy has been just now declared at Court; in Consequence of which, publick Prayers are to begin To-morrow in all the Churches of this Kingdom, for her Majesty's approaching Delivery.

Vienna, June 9. Their Imperial Majesties, on their Return from Laxemburg to Schonbrun, took Erlaw in their Way, a fine Country Seat belonging to Count Uhlfeld, who had the Honour to entertain their Majesties with a magnificent Dinner.

Munich, June 9. The greatest Part of the Artillery of this Electorate, which had been taken during the late War by the Austrian Troops, has been restored, in Consequence of the Orders given by the Empress Queen; and the Remainder is soon expected. Baron Widmann, their Imperial Majesties Minister Plenipotentiary

at this Court, intends to set out very soon for Carlsbad; having been advised by his Physicians to repeat the Use of the warm Baths of that Place.

Ratisbon, June 9. The Imperial Chamber of Wetzlaar, have renewed their Instances to the Diet, in order to obtain proper Orders for the Payment of the Arrears due to them by several Princes and States of the Empire. Chevalier Follard, the French Minister, is returned hither from a Journey he has lately made to the Court of Bareith.

Dresden, June 10. The Troops which are encamped at Ubigau, in the Neighbourhood of this Capital, are daily exercised in all such Branches of the Military Duty, as may be required in Time of War. Last Thursday the Horse and Foot, having been divided in two Corps, and drawn up in Battle Array, made a feign'd Engagement. During the whole Action, their Royal Highnesses the Princes Xavier, Charles and Clement, the prime Minister Count Bruhl, and Prince Lubomirsky, commanded at the Head of their respective Corps. The next day they performed another Exercise, with no less Order and Dexterity, at which were present the whole Court, and a great Number of General Officers in the Service of Foreign Princes; which began by opening of Trenches before a Kind of Fort, built for that Purpose, which is not to be surrendered to the Besiegers, till it has sustained their Attacks for three Days. When that Siege is finished, the Army is to decamp, and the Regiments, of which it is composed, are to return to their former Quarters, or to those which the Court may think proper to assign them.

Berlin, June 12. The King's Return hither from Prussia is hourly expected, and the necessary Relays have accordingly been made.

Hague, June 17. The States of the Province of Holland and Westfrizeland have separated, and are to resume their Deliberations on Wednesday the 27th Instant. The Duke of Modena having acquainted the States General with the Death of the Prince his Grandson, their High Mightinesses have resolved to write a Letter of Condolance to his Serene Highness, upon that melancholy Occasion.

Hague, June 19. The Day of the Court's Departure for Dieren, is not yet determined; and 'tis said will not take Place before the 15th or 20th of next Month.

The King has been pleased to grant unto the Right Honourable Charles, Baron Cornwallis, and to the Heirs Male of his Body, lawfully begotten, the Dignities of a Viscount and Earl of the Kingdom of Great Britain, by the Name, Stile and Title of Viscount Brome, in the County of Suffolk, and Earl Cornwallis.

The King has been pleased to constitute and appoint George Colingwood, Esq; to be Lieutenant Governor of the Island of Jersey, and of the Forts and Garrisons therein and thereunto belonging, whereof Lieutenant General Husk is Governor, in the Room of William Deane, Esq;.

The King has been pleased to constitute and appoint Thomas Lacey, Esq; to be Lieutenant Governor of the Castle of Tinmouth, in the County of Northumberland, and of the Forts and Fortifications thereunto belonging, whereof Sir Andrew Agnew, Bart. is Governor.

The King has been pleased to constitute and appoint Alexander Trapaud, Esq; to be Deputy Governor of the Fort called Fort Augustus, in that Part of the Kingdom of Great Britain called Scotland.

The King has been pleased to constitute and appoint his Grace Charles Duke of Richmond to be Captain of a Company, in the Regiment of Foot commanded by George Keppel, Esq; commonly called Lord Viscount Bury.

The King has been pleased to grant unto George Norbury, Gent. the Office of Constable of the Castle of Chester, in the Room of Walter Warburton, deceased.
