A PROCLAMATION.

GEORGE R.

WHEREAS our Parliament stands prorogued to Thursday the Twenty-seventh Day of this Instant September; We, with the Advice of our Privy Council, do hereby Publish and Declare, That the said Parliament shall be further prorogued on the said Twenty-seventh Day of September, to Thursday the Fifteenth Day of November next: And we have given Order to our Chancellor of Great Britain, to prepare a Commission for proroguing the same accordingly. And we do hereby further Declare our Royal Will and Pleasure, That the said Parliament shall, on the said Fifteenth Day of November next, be held, and sit for the Dispatch of divers weighty and important Affairs: And the Lords Spiritual and Temporal, and the Knights, Citizens, and Burgeses, and the Commissioners for Shires and Burghs of the House of Commons, are hereby required to give their Attendance accordingly at Westminster on the said Fifteenth Day of November next.

Given at our Court at Kensington the Twenty-sixth Day of September 1753, in the Twenty-seventh Year of our Reign.

GOD Save the KING.

The King's most Excellent Majesty in his Privy Council.

Whereas William Cuthbertson, William Steedman, William Baird, Adam Lillie, James Manson, James Lillie, and William Lennox, all Boatmen at Aberdour, were upon the Twenty-third Day of July last charged by Information of a credible Person upon Oath, by him subscribed before Mr. Archibald Murray, of Murrayfield,

Advocate, one of his Majesty's Justices of the Peace of the County of Edinburgh in Scotland, with having been guilty, upon the Eighth Day of the said Month of July, of being, together with diverse other Persons, assembled at Dalgety in the County of Fife; and there having surrounded four Soldiers who were employed to defend a Seizure, made by a Custom-house Officer, of Twenty-nine Anchors of Run Brandy, wrested and took from them their Arms, and deforced the said Custom-house Officer, and took away the Brandy.—Which Information was afterwards certified by the said Archibald Murray, under his Hand and Seal, to one of his Majesty's Principal Secretaries of State, who has laid the same before his Majesty in his Privy Council, pursuant to the late Act of Parliament of the Nineteenth Year of the Reign of his present Majesty in that Case made and provided.—His Majesty doth, by and with the Advice of his Privy Council, by this his Order in his Privy Council, require and command, that the said William Cuthbertson, William Steedman, William Baird, Adam Lillie, James Manson, James Lillie, and William Lennox, and each of them, do surrender himself and themselves, within the Space of Forty Days after the first Publication of this Order in the London Gazette, to any of the Lords of Justiciary, or to any one of his Majesty's Justices of the Peace in Scotland.

Copenhagen, Sept. 15. Yesterday the Queen Dowager, after having dined with her Sister the Princess Dowager of Ostfriesland, accompanied by the said Princess and the young Princess of Culmbach, her Neice, with a Retinue of about twenty Persons, went to the Country House of Walter Titley, Esq; his Britannick Majesty's Envoy Extraordinary to this Court, and the Weather being very fine, her Majesty walked for some Time in the Gardens, and afterwards accepted of a Collation, at which her Majesty drank his Britannick Majesty's Health, wishing his Majesty long Life and Prosperity, and

and likewise drank to the British Royal Family, and to the Welfare of the British Nation in general; and it is said that the King of Denmark intends to do the said Minister the Honour of dining at his House, as usual, on the 26th Instant. On the 13th Instant the Spanish Envoy had an Estafette from his Court, with Orders, as it is said, to leave this Place in a Fort-night's Time, and to repair to Stockholm, where he is to reside in the same Character he had here. We are told likewise that Baron Vence, is actually upon the Road hither. Baron Sacken, Envoy Extraordinary from his Polish Majesty to the King of Sweden, is here at present with his Lady, having taken this Place in his Way to Stockholm.

Hambourg, Sept. 18. The French Envoy received, two Days ago, by an Express, the News of the Dauphiness's being happily delivered of a Prince, who is to bear the Title of Duke of Aquitain, and notified it in Form to all the Foreign Ministers, &c. The same Messenger went on for Berlin, and had passed at the Court of Cologne, where he had been gratified by his Electoral Highness with a Present of 100 Ducats. Their Swedish Majesties, with the young Princes, are arrived in perfect Health at Stockholm, as the Time of her Majesty's Delivery is nigh at Hand.

Hambourg, Sept. 21. The Magistrates of Hambourg having received certain Advice, that the Plague had manifested itself this Year upon the Island of Rhodes, (as they express themselves in an Advertisement published here the 17th Instant) have given the necessary Orders at proper Stations, for the strict Observance of their Edict of the 28th of January, in the Year 1752. Which directs, That no Vessel, from any suspected Quarter, should be piloted into the Elbe, nor to suffer any Merchandizes, coming directly from the Levant, and susceptible of Infection, to be unloaded; and this Notice is given, for the Information of all Masters of Ships, and Merchants concerned in their Cargoes.

Hague, Sept. 21. The French Ambassador presented a Memorial Yesterday to the States-General, in the Name of his most Christian Majesty, desiring their High Mightinesses would be pleased to deliver up the Author of a Libel published at Amsterdam, and who is actually confined there, entitled, *La Voix des Persecutés*, containing several Invectives against the Government of France. It is not however on that Account that his most Christian Majesty reclaims him, but because he had fled from France, after having committed several Crimes, and particularly assassinating an Inn-keeper at Rouen. The said Author was formerly in the Musqueteers, and is a Gentleman; and it is said, that his most Christian Majesty will not put him to

Death, but shut him up in Prison. The States General have accepted the Memorial, and recommended it to the States of Holland, and it is thought he will be given up accordingly. The States of Holland are still assembled, and the Affair of the Free Port continues under Deliberation. The Time of her Royal Highness the Princess Governante's Return is still uncertain.

Dublin Castle, Sept. 21.

His Grace the Duke of Dorset, Lord Lieutenant of this Kingdom, embarked at Holyhead Yesterday at One of the Clock in the Afternoon, and landed at Dunleary within four Miles of Dublin at Six this Morning.

The Right Hon. the Lords Commissioners of His Majesty's Treasury having appointed Money for paying Half Pay to Sea Officers, from the 31st of December 1752, to the 30th of June 1753, according to his Majesty's Establishment on that Behalf;
