Constantinople, June 16.

HE Disgrace of the Musti has sollow-ed that of the late Grand Vizier. Every Thing is now quiet in this City; neither do we perceive the least Appearance of any contagious Distemper, which generally used to rage about this Time of the Year.

Madrid, June 24. We have received Advice, that several Fathers of the Order of the Trinitarians arrived on the 10th and 12th Instant at Carthagena from Algiers, with 325 Christian Slaves, whom they had lately redeemed.

Genoa, June 28. On the 21st Instant a new Galley was launched in this Arfenal, which had been contracted for, for his Sardinian Majesty's Service. As soon as the was a float, the Officers, who came on Purpose from Villafranca, with Slaves, Seamen and others, took Possession of her, and having fitted her out, she departed last Night for Villafranca. On the 26th at Night, two of this Republick's Galleys failed for Calvi, having on board Seven Compahies of Soldiers to change the Garrison of that Place and Ajaccio. The new Road that is making from Sestri di Levante into the State of Parma, is carried on with the greatest Diligence, and it is said will be compleated this Summer. The Preparations for Building a Castle at St. Remo, are carried on with Vigour: Large Quantities of Materials have been sent thither, and they have begun to drive the Piles for the Foundation, having erased an old Church that flood on the Ground where the Castle is to be built. Letters from Bastia of the 21st Instant advise, that a Resolution had been taken in the late General Assembly of the Malecontents, to appropriate all the Fruits and Tenths belonging to the Bishops and Canons of the Island, to enable them to oppose the Republick; that several other Malecontents were returned to the Island to join their Partizans, and had industriously spread a Report, of having brought with them a Supply of 24000 Livres. The Malecontents have burnt and destroyed the Fattoria called the Procoia in Fiumorbo, belonging to the Families of Fieschi and Spinola of this City; and their Agent, with his Family, has been obliged to take Refuge in Bassia.

Rome, June 28. On the 18th Instant Cardinal Besozzi died at Tivoli, after a lingering Illness; by whose Death there are ten vacant Hats in the College of Cardinals, including that which the Pope res rved in petto at the last Promotion. By the last Letters from Ancona we

have received the disagreable News, that they had felt a terrible Shock of an Earthquake, which had occasioned considerable Damage. On the 24th the Margtave and Margtavine of Bareith, went to see the Country Seat of Cardinal Valenti, and were splendidly entertained there by his Order. On the 26th the Pope, attended by his Retlnue and Guards, returned to this City from Castle Gandolfo, and the Eve of the Festival of St. Peter received the Hackney, as a Tribute for the Kingdom of Naples; which Ceremony was as usual performed by the Constable Colonna.

Modena, July 2. The Departure of the Duke our Sovereign on his Return to Milan, being fixed for Monday next, the Detachments, appointed to escort his Serene Highness on the Road, are already ordered to their respective

Posts.

Vienna, July 2. Their Imperial Majesties propose to return next Saturday from Laxembourg to Schonbrun. Field Marshal Count Brown, Commander in Chief of the Imperial Troops in Bohemia, is expected here To-day of To-morrow from Prague, to affist at a grand Council that is to be held at Court on Military Affairs; after which that General intends to let out for Trieste, to review his Regiment which is there in Garrison.

Florence, July 5. The 24th of June, being the Festival of St. John, Count Richecourt, by a particular Commission from the Emperor to represent his Person on that Occasion, received. with the usual publick Formalities, the Homage from the respective Cities, Towns and Feudatories of Tuscany, being attended by all the different Magistrates and Nobility. On the 30th Count Richecourt set out for Siena, in Company with M. Martini, the Pope's Inter-Nuncio, to establish the Tribunal of the Inquisition, upon the same Foot as had been done at Florence, Pisa, &cc.

Turin, July 5. The 30th of last Month the King, and the rest of the Royal Family, came hither from the Venerie. M. Barry, the Imperial Secretary to this Court, being recall'd, set out last Thursday on his Return Home.

Copenhagen, July 5. The King has made a numerous Promotion of Military Officert, amongst whom the young Prince of Holstein-Augustenbourg, Count Laurwig, Count Wedel-Jarlsberg, and Mess. de Windtz, Lutzow, Levenbourg, and Hauch, were promoted to the Rank of Majors General of Foot; as were Count Plessen, and the Barons de Schenck and Rieppur, to that of Majors General of Horse.

His Majesty has appointed M. Huitseld, one of his Aids de Camp, and M. Schaffalisky, Captain in the Horse Guards, to be his Chamberlains. General Count Nummesen, who commanded the Troops lately encamped near this City, having obtained the King's Leave to spend some Time at his Seat in the Island of Laland, he is accordingly set out for that Island.

Berlin, July 8. We learn from Prentlow, that the young Princess, of whom the Princess of Hesse Darmstadt was delivered on the 25th of last Month, was baptized on the 29th by the

Brussels, July 10. Prince Charles of Lorrain, our Governor General, returned here last Thursday from Ter-Vuren, and on the Monday following set out with a numerous Retinue for Little Willebroek, in order to see the Works carrying on at the Canal. Count Czernichew, Minister from Russia to the Court of Great Britain, arrived here with his Spouse last Saturday from London, on his Return to Petersbourg by the Way of Hanover.
