WHEREAS the Time limited by His Majesty's Order in Council, of the Nineteenth of December last, For paying the respective Bounties therein mentioned, to all Able and Ordinary Seamen, and also to all Able-bodied Landmen, who should voluntarily enter themsclives in His Majesty's Royal Navy; and like-wise for paying the Rewards to Persons disco-vering Seamen who should conceal themselves, will expire upon the 28th Day of this Instant February; And whereas it is judged expedient for His Majesty's Service, That the Bounties and Rewards thereby given, should be continued to be paid for some Time lenger; — His Majesty doth therefore, by and with the Advice of His Privy Council, hereby Order, That the Bounties of Three Pounds for every Able Seaman, and of Thirty Shillings for every Ordinary Seaman, not above the Age of Fifty, nor under the Age of Twenty Years; and of Thirty Shillings for every Able-bodied Landman, not above the Age of Thirty-five, nor under the Age of Twenty Years, be continued to be paid to fuch Seamen and Landmen respectively, who shall, on or before the 21st Day of April next, enter themselves in the Royal Navy, immediately after the first Muster of such Seamen and Landmen, and in all other Respects in the Manner directed by His Majesty's Proclamation of the 4th Day of January 1757: And likewise, That the Rewards of Two Pounds for every Able, and Twenty Shillings for every Ordinary Seaman, be continued to be paid to any Persons who shall, on or before the said 21st Day of April next, discover any Seaman or Seamen who shall conceal themselves, so as such Seaman or Seamen be taken for His Majesty's Service. Whereof all Persons concerned are to take Notice, and govern themselves accordingly. F. Vernon.

Admiralty Office, December 26, 1758 Y Lords Commissioners of the Admiralty, having received authentick Information, that a Galliot or Vessel, called the Justrow Christina Elizabeth of Lubeck, whereof Casper Muntzenberger was Master, laden with different Kinds of Goods and Merchandize, belonging to the Subjects of the Empress of Russia, and bound from Rouen to St. Petersbourg, was, in the Course of her said Voyage, on the 18th Day of September last, boarded three several Times by the Crews, or Part of the Crews, of fix English Ships or Vessels, being, or pretending to be Privateers; and that at the first of those Times, viz. about One a-Clock in the Afternoon of that Day, fome of the Crews of the faid English Ships boarded the faid Galliot off Dungeness, and opening the Fore Hatchway, went into the Hold, and broke open a great many Cases, and Packs of Merchan-dize, and unlawfully took, and carried away, great Quantities of Velvets, Silks, Silk-Stockings, Gloves, Confectionary Goods, and one whole Bale of Silk: And that between Three and Four a Clock in the fame Afternoon, being off Dover, the faid Galliot was again boarded by the Crews, or Part of the Crews, of three other English Ships, who being in Company, went together into the Hold, and rummaged the faid Galliot, and unlawfully took, and carried away, some Silk, and Silk-Stockings, Part of which they wrapped about their Bodies, and put the rest into their Pockets, and also took away a Sword: And that foon afterwards, on the fame Day, the faid Galliot was a third Time boarded by the Crew, or Part of the Crew of another English Ship, who went into the Hold, broke open several Cases, and unlawfully took, and carried away, two Boatloads of Merchandize, confisting of Men and Wo men's Velvets, Silk, embroidered Cloaths, Silk-Stockings, Leather Gloves, French-Plate Candlesticks, some Swords, and Hangers, Bottles of Cordials, Perfumes, and Confectionary and other Goods; nad then beat several of the said Galliot's Crew, and confined the faid Master in his Cabbin, placing a Centry over him with Piffols:

Their Lordships therefore, in order to discover and bring to Justice, the Persons guilty of the Piratical Offences above-mentioned, are pleafed to pro-mife a Reward of FIVE HUNDRED POUNDS, without any Deduction, unto or amongst such Perfon or Persons, as shall, within three Months from this Time, discover any one or more of the Offenders concerned in Committing all or any of the Piracies above-mentioned, so as such Offender or Offenders shall be apprehended and duly convicted thereof: Which Reward shall be paid by Samuel Seddon, Esq; Solicitor of the Admiralty, immediately after the Conviction of fuch Offender or Offenders

And as a further Encouragement, any of the faid Offenders, (other than and except the respective Commander or Commanders of any of the abovementioned English Ships or Vessels) who shall discover any one or more, other of the faid Offenders, shall, on the Conviction of the Offender or Offenders so difcovered, be likewise entitled to His Majesty's most gracious Pardon.
