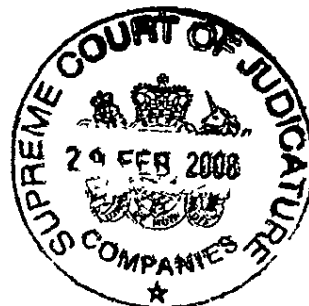
AND UPON READING the evidence, including the details of the Company's insurers as known at the date hereof, as set out in the annex to this Order
