S. Lyles Sons & Co Limited - In Administration ("the Company")

We now supply our final report in respect of the above matter and report as follows:

- 1 Statutory Information
- 1.1 The Joint Administrators are Francis Graham Newton and Toby Scott Underwood of BDO LLP, 1 Bridgewater Place, Water Lane, Leeds, LS11 5RU and they were appointed in respect of the Company on 14 July 2009. Under the provisions of paragraph 100(2) of schedule B1 of the Insolvency Act 1986 the Administrators carry out their functions jointly and severally and either Administrator has exclusive power to exercise any function.
- 1.2 We were appointed by the Directors of the Company pursuant to Paragraph 22 of schedule B1 of the Insolvency Act 1986. The Administration proceedings are dealt with in the Leeds District Registry and the court case number is 1923 of 2009
- 1 3 The Company's registered office is situated at BDO LLP, 1 Bridgewater Place, Water Lane, Leeds, LS11 5RU and the registered number is 00120255.
- 1.4 We enclose, for your information, a summary of our receipts and payments to date which shows a nil balance and report as follows
- 2 Receipts

The receipts shown are largely self-explanatory, although we would comment specifically on the following:

- 2.1 Sale of plant and machinery
- 2 1.1 A contract for sale of the majority of the plant and machinery was exchanged on 26 November 2009. Completion of the sale concluded on 30 March 2010
- 2.1 2 The consideration of £1.67m has been received in full.
- 2.1.3 All remaining items of plant and machinery, fixtures and fittings and computer equipment have been sold by our agents, realising c£6k





#### 2.2 Book debts

- 2.2 1 Barclays Sales Finance ("BSF") provided an invoice financing facility to the Company. At the date of our appointment, c£1.8m was outstanding to BSF, secured over the debtor ledger which totalled c£2 6m.
- 2.2.2 Collections have been completed and BSF's debt, £1.9m, has been repaid in full.
- 2.3 Freehold land and buildings at Calder Bank Mills, Calder Bank Road, Dewsbury ("the Property")
- 2.3.1 The sale of the Property to Westex (Carpets) Limited completed on 2 July 2010 The total consideration, £2.2m, has been received in full.
- 2.4 Other plots of land
- 2 4.1 We investigated the Company's ownership of three small plots of land separate from the Property. Only two of these plots of land were owned by the Company
- 2 4 2 Both of these plots of land were sold at auction realising £10k.
- 3 Administrators' Trading
- 3.1 Trading ceased on 11 September 2009 following completion of all confirmed sales orders.

  All 274 staff were made redundant.
- 3.2 Sales during the Administrators' trading period totalled £820k net of VAT, resulting in a trading profit of £210k
- 4 Other Matters
- 4.1 We instructed Rogerson & Associates Chartered Surveyors to undertake a review of the historic business rate payments. This resulted in a refund of £12k arising to the Company.
- 5 Future of the Administration
- 5.1 As detailed in the Joint Administrators proposals, which were accepted at the meeting of creditors held on 21 September 2009, it was anticipated that the Company would move from Administration to either Creditors' Voluntary Liquidation or dissolution
- 5.2 As no dividend will be paid to the unsecured creditors, the Company will move from Administration to dissolution.
- 6 Prospects for Creditors
- 6.1 Prescribed Part
- 6.1.1 Due to the Company not granting a floating charge after 15 September 2003 this provision does not apply



#### 6.2 Secured creditors

- 6.2.1 The primary debts of Barclays and BSF have been repaid in full
- 6.2 2 Additional repayments totalling £106k have been paid to BSF in respect of contractual interest charges and termination fees.

#### 6.3 Preferential creditors

- 6 3 1 Preferential claims only typically arise in respect of employees' arrears of wages and unpaid holiday pay.
- 6 3.2 Total preferential claims amount to c £247k. There have been insufficient realisations to enable a distribution to the preferential creditors.

#### 6.4 Unsecured creditors

- 6 4.1 We have received claims from unsecured creditors totalling £6 36m
- 6 4.2 There have been insufficient realisations to allow a distribution to the unsecured creditors.

#### 7 Administrators' Remuneration

- 7.1 The creditors have already approved the Administrators' remuneration on a time cost basis at the meeting of creditors held on 21 September 2009. The amount of time spent administering the case totals £627k. This relates to 3,341.65 hours of work at an average rate of £187.69 per hour. We have drawn fees of £605k
- 7 2 We attach a schedule which summarises the time costs accrued to date and details the work undertaken.

#### 8 Disbursements

8.1 Where disbursements are recovered in respect of precise sums expended to third parties there is no necessity for these costs to be authorised. These are known as category 1 disbursements. Total disbursements of £10k have been drawn in respect of category 1 disbursements as follows:
