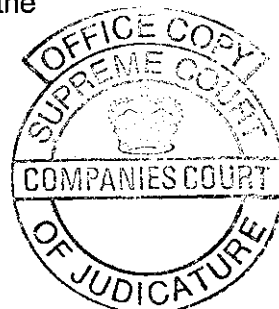
UPON THE APPLICATION by a Claim Form dated the 18<sup>th</sup> September 2003

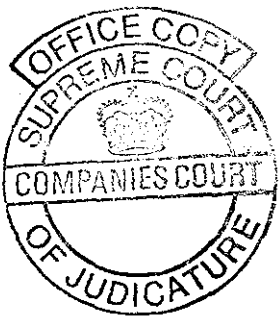

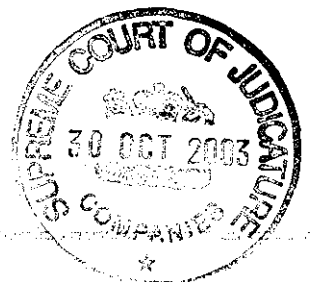
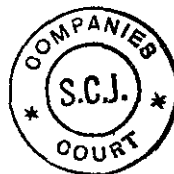
AND UPON the solicitors for the Claimant and for the Registrar of Companies

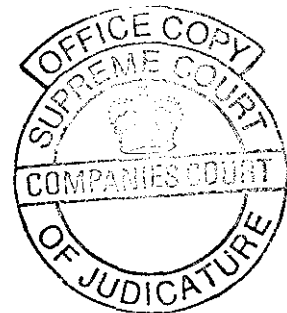
