AND UPON READING the evidence

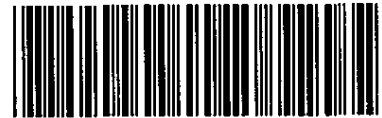

AND UPON the solicitors for the Claimant and for the Registrar of Companies (the Defendant) both consenting to this Order


IT IS ORDERED THAT


(6) the Registrar of Companies do advertise notice of this Order in his official
