- (6) in the event that the Claimants fail to comply with undertaking (B) above the Registrar of Companies be at liberty to commence strike off action in respect of the Company without further notice to the Claimants
- (7) the Claimant do pay to the Registrar of Companies his costs of the said Application in the agreed sum of £300-00
