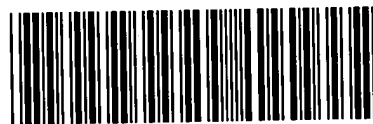

- Prepare the financial statements on the going concern basis unless it is inappropriate to presume that the Company will continue in business.

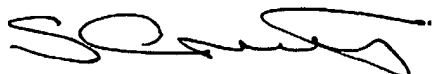
