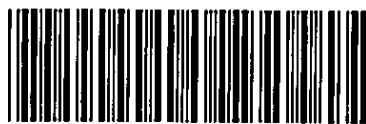
AND UPON READING the evidence

- (4) the Registrar of Companies do advertise notice of this Order in his official name in the "London Gazette"
- (5) the Claimant pay to the Registrar of Companies his costs of the said Application in the agreed sum of £300-00
