





Disabled People's Employment Corporation (GB) Limited - in members' voluntary liquidation (the Company)

Laura May Waters and Robert Nicholas Lewis were appointed joint liquidators (the liquidators) of the Company on 7 October 2017.

As required by current legislation, we are required to provide:

- you with a report on the conduct and progress of the liquidation for the period 7 October 2018 to 6 October 2019 (the Period); and
- certain information concerning the Company and the liquidators; this information is attached as appendix A.

A summary of receipts and payments for the Period is attached as appendix B.

PROGRESS REPORT ON THE LIQUIDATION

Realisation of assets:

The directors' Declaration of Solvency showed the Company's assets consisted of:

As the Previous Report noted, at the time of our appointment, the only assets were 2 laptop computers, the value of which had been written down to £1. Following our appointment, these were taken under control until distribution.

The Previous Report also noted that we'd realised a total of £34,661.98 from the Company's other assets which were also taken under our control until distribution.

During the Period we've not identified any additional assets. There are no assets still to be realised.

Settlement of liabilities:

This section covers all liabilities except any claims of HM Revenue & Customs (HMRC) which are dealt with separately below under HMRC.

The Previous Report noted there were a number of ongoing claims against the Company. There continues to be a number of ongoing claims against the Company. These are being dealt with by the Company's insurers or by the Department for Work and Pensions. The liquidation remains open whilst these claims are being addressed.

HMRC:

We are seeking HMRC's confirmation that all corporation tax, VAT and PAYE matters have now been resolved and there is no objection to the closure of the liquidation.

Distributions:

The Company is a company limited by guarantee and does not have share capital. Any distribution is payable to the Department for Work and Pensions.

No distributions have been made during the period.

LIQUIDATORS' REMUNERATION AND EXPENSES

Basis of remuneration:

At the time of our appointment, a resolution was passed for us to be paid by reference to the time properly given by us and our staff in dealing with the liquidation.

During the Period, £11,521 plus VAT of time costs have been incurred and invoiced in respect of the liquidation. It is our normal practice to obtain the prior approval of the Department for Work and Pensions before fees are invoiced and paid by the Department for Work and Pensions.

Liquidators' expenses:

During the Period we have incurred category 1 expenses of £310 plus VAT. These costs, which will be or have been re-charged

1. Category 1 expenses represent specific expenditure incurred directly in respect of this liquidation and payment has been to independent third parties.

Members' rights re liquidators' remuneration and expenses:

Members with at least 5% of the total voting rights of all the members having the right to vote at general meetings of the company (or permission of the court) are entitled to request further information about our fees and expenses. Such requests need to be made within 21 days of receipt of this report. See Rule 18.9 of the Insolvency (England and Wales) Rules 2016 for further detail.

Members with at least 10% of the total voting rights of all the members having the right to vote at general meetings of the company (or permission of the court) are entitled to claim by way of court application that the liquidators' fees and expenses are excessive. Such applications need to be made within 8 weeks of the receipt of this report. See Rule 18.34 of the Insolvency (England and Wales) Rules 2016 for further detail.
