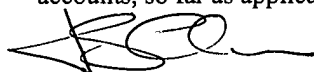
For the period ended 4 October 2015 the company was entitled to exemption from audit under section 480 of the Companies Act 2006.

NOTES TO THE ACCOUNTS - 4 October 2015

1 ACCOUNTING POLICIES

1.1 BASIS OF PREPARATION OF FINANCIAL STATEMENTS

The financial statements have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008).

1.2 RELATED PARTY TRANSACTIONS

In accordance with Financial Reporting Standard 8, the company is exempt from the requirement to disclose related party transactions with fellow group companies as its ultimate parent company, BMM Weston Holdings Limited, publishes consolidated accounts.

- 2 During the period the company has not traded, has not incurred any liabilities and consequently has made neither profit nor loss. The director received no emolument in respect of his services to the Company.

3. CALLED UP SHARE CAPITAL

The authorised share capital consists of 300 shares of 33 1/3p each of which 180 shares are allocated and fully paid

4. ULTIMATE HOLDING COMPANY AND CONTROLLING PARTY

The company is a wholly owned subsidiary of BMM Weston Limited. The ultimate holding company is BMM Weston Holdings Limited, a company incorporated in England. The company is controlled by the director Mr J S Cleaver and Mrs B Cleaver by virtue of their combined interest in 100% of the ordinary shares of that company.
