POWER OF ATTORNEY

1. Appointment and Powers

- 1.2 generally execute any deed or sign any document which may be required and to do any other act matter or thing which the Attorney shall consider necessary or expedient for carrying out any of the purposes or acts hereby authorised in the same manner and as fully and effectively in all respects as the Principal could have done if personally present.

2. Substitute Attorney

For the purposes of clause 1 of this Power of Attorney, each of the Attorneys may appoint and remove at their pleasure any substitute for or agent under him upon such terms as the Attorney shall think fit PROVIDED THAT such substitute or agent shall be authorised to act as an Insolvency Practitioner within the meaning of Section 390(2) of the Act.

3. Principal's Undertaking

The Principal hereby undertakes to ratify everything which the Attorney or any substitute or agent appointed by him under clause 2 shall do or purport to do, in good faith, in the exercise of any power conferred by this Power of Attorney.

4. Jurisdiction

This Power of Attorney (and any dispute, controversy, proceedings or claim of whatever nature arising out of or in any way relating to this Power of Attorney, its formation or any act performed or claimed to be performed under it) shall be governed by and construed in accordance with English law.
