I refer to my appointment as liquidator of the Company by its sole shareholder on 5 September 2016.

Realisation and distribution of assets

At the commencement of the liquidation and according to the directors' statutory declaration of solvency made on 5 September 2016, the Company's sole asset was an inter-company receivable of £10 due from RMC Dormant No 4 Limited (RMC).

Attached at Appendix 2 is an abstract of my receipts and payments account for the period to 28 April 2017. On 18 April 2017, the Company's assets were distributed in specie to its parent company, RMC, by way of a deed of distribution. The value placed upon the distribution was based upon the last management accounts for the period ending 31 May 2016 and the declaration of solvency dated 5 September 2016.

During the liquidation, time has been spent by my staff liaising with HM Revenue & Customs ('HMRC') to conclude the Company's tax and VAT compliance.

Written confirmation has been received from HMRC, in respect of 'all taxes', that the Company has no further outstanding matters and it does not have any objection to the liquidation being closed.

On 5 September 2016 the Company's sole shareholder resolved that my fees for acting as liquidator be fixed by reference to my time costs. Disbursements have been incurred in relation to statutory advertising and bonding only.

Appendix 2 - Rule 4.49E: Members' request for further information (edited for application to a members' voluntary liquidation)

- 1. Members of the company with at least 5% of the total voting rights of all the members having the right to vote at general meetings of the company, or with the permission of the court upon an application, may make a request in writing to the liquidator for further information about remuneration or expenses set out this report.
- 2. The periods in which the request or application should be made are:
 - (a) 7 business days of receipt (by the last of them in the case of an application by more than one member) of the notice and account of his administration of the winding-up where it relates to the resignation of the liquidator under Rule 4.142, and
 - (b) 21 days of receipt (by the last of them in the case of an application by more than one member) of the report or draft report in any other case.
- 3. The liquidator must, within 14 days of receipt of the request, either:
 - (a) provide all of the information asked for, or
 - (b) so far as the liquidator considers that
 - (i) the time or cost of preparation of the information would be excessive, or
 - (ii) disclosure of the information would be prejudicial to the conduct of the liquidation or might reasonably be expected to lead to violence against any person, or
 - (iii) the liquidator is subject to an obligation of confidentiality in respect of the information,
 - give reasons for not providing all of the information.
- 4. Any member of the company, who need not be the same as the member(s) who asked for the information, may apply to the court within 21 days of the giving by the liquidator of reasons for not providing all of the information asked for, or the expiry of the 14 days from the date the information was requested, and the court may make such order as it thinks just.
