If this order has been made in the absence of the parties, any party affected may apply, within 7 days of receipt, to vary it or set it aside.

The District Judge has considered the statements of case and allocation questionnaires filed and allocated the claim to the **fast track**

The trial of this claim will take place during the period commencing 19 September 2016 and ending on 7 October 2016 with a time estimate of 1 day at a venue to be notified

The District Judge orders that you and the other parties prepare for the trial as follows:-

IT IS ORDERED THAT

- 1 The Claim be allocated to the Fast Track
- 2 The dissolution of the Defendant Company be deferred until 1 January 2017
- 3 The Claimant do within 21 days from the date hereof deliver an Office copy of this Order to the Registrar of Companies and the Liquidator
- 4 Each party to provide standard disclosure of documents on Form N265 by 4pm on 9 December 2015 Request for inspection or copies to be made within 7 days of disclosure
- 5 Each party shall exchange witness statements of fact by 4pm on 1 February 2016

6 Permission be granted to the Claimant to use in evidence the expert medical report of Mr Sharma, Consultant Orthopaedic Surgeon, dated 28 October 2014 and a second report following surgery. Such report to be served by 29 April 2016

7 Any questions the parties wish to put to the expert shall be served by 13 May 2016. Replies to be served by 3 June 2016

8 The Claimant do serve an updated Schedule of Special Damages by 17 June 2016

9 The Defendant do serve a Counter-Schedule of Special Damages by 1 July 2016

10 Each party do file Pre-Trial Checklists by 4pm on 23 July 2016.

11 The Claim be listed for trial with a time estimate of 1 day during the Trial Window commencing 19 September 2016 to 7 October 2016

12 Costs in the case

The claimant must pay a hearing fee of £545 00.

If the court is notified in writing that the hearing is no longer needed the hearing fee will be refunded in full or in part in certain circumstances, please refer to the leaflets explaining more about what happens when your case is allocated to track
