- 1. The name of the Company (hereinafter called "the Company") is "GRANGE ROAD MANAGEMENT COMPANY LIMITED".
- 2. The registered office of the Company will be situate in England.
- 3. The objects for which the Company is established are:-
 - (a) To enter into and carry into effect 18 deeds of variation intended to be executed by Velma Property Co. Limited of the first part—the Company of the second part the several lessees of flats 30 to 64 (even numbers) Grange Road Harrow in the County of Middlesex of the third part and their respective mortgagees of the fourth part in the terms of a draft which has been marked "A" and signed for the purposes of identification by
 - (b) To manage the Block of Flats and the land enjoyed therewith situate at 30 to 64 Grange Road aforesaid and to provide services to the lessees and occupiers of the flats comprised therein.
 - (c) To acquire and hold land and other property as an investment and to manage the same.
 - (d) To borrow and raise money in such manner as the Company shall think fit.

- (e) To undertake and execute any trusts which may lawfully be undertaken by the Company and may be conducive to its objects.

General

1. In these regulations "owner" shall mean a person who is the holder as lessee or the persons who are jointly the holders as lessees for the time being of one of the leases granted by Velma Property Co. Limited in 30 to 64 (even numbers) Grange Road, Harrow in the County of Middlesex or of a lease granted in substitution for one of such leases.

PART I.

- 2. In case of any inconsistency between the regulations contained in Part II hereof and any regulations otherwise applicable to the Company the regulations contained in Part II hereof shall prevail provided that in no case shall such regulations operate in such a way that the Company ceases to be a Private Company.
- 3. Subject to regulation 2 hereof Part II of Table A in the First Schedule to the Companies Act, 1948 (hereinafter called "Table A") shall apply to the Company.

PART II.

- 4. Regulation 3 of Table A Part II shall not apply.
- 5. (a) One share in the Company shall be allocated to each of the flats numbered 30 to 64 (even numbers) Grange Road aforesaid.
- (b) There shall as soon as may be after the formation of the Company be made such transfers of shares and allotments as shall ensure that the owner of each flat holds whether by transfer or allotment in respect of each flat one and only one share in the Company being the share allocated to that flat as aforesaid and that no person who is not the owner of a flat at 30 to 64 Grange Road aforesaid holds any share in the Company.

- 6. (a) A share shall be transferred and may only be transferred upon or immediately before a change in the ownership of a flat and to the person becoming or about to become upon such change the owner of such flat.
- (b) The price to be paid upon the transfer of a share shall in default of agreement between the transferor and transferee be its nominal value.
- (c) If the holder of a share refuses or neglects to transfer it in accordance with this regulation the Chairman for the time being of the directors or failing him one of the directors duly nominated by resolution of the Board for that purpose shall forthwith be deemed to be the duly appointed attorney of that holder with full power in his name and on his behalf to execute, complete and deliver a transfer of his share to the person to whom it should be transferred hereunder and the Company may receive and give a good discharge for the purchase money and enter the name of the transferee in the register of members as the holder by transfer of the said share.
- 7. If two or more persons are jointly the owners of a flat such persons shall jointly hold the corresponding share in the Company but shall have only one vote in right of such share, whether as members or directors, which shall be cast by the holder whose name first appears in the register of members.
- 8. The provisions of Table A as to the appointment rotation and removal of directors shall not apply. All the members of the Company for the time being shall be its directors provided that a member being a body corporate shall not be a director but shall appoint a natural person to be a director.

PART III.

- 9. In Regulation 1 of Table A, Part I, the words "and in any Articles adopting the same" shall be inserted immediately after the word "regulations" where it first occurs.
- 10. In Regulation 11 of Table A, Part I, the words "(not being a fully paid share)" and "(other than fully paid shares)" shall be omitted.
- 11. In Regulation 15 of Table A, Part I, the words from "provided that" to "the last preceding call" inclusive shall be omitted.
- 12. In Regulation 23 of Table A, Part I, for the words "instrument in writing" there shall be substituted the word "deed".
- 13. Regulations 40 to 43 inclusive of Table A, Part I, shall not apply.

- 14. In Regulation 49 of Table A, Part I, for the words "any two members" shall be substituted the words "any member".
- 15. In subclause (b) of Regulation 58 of Table A, Part I, for the words "at least three members" there shall be substituted the words "any member" and subclauses (c) and (d) of the said regulation shall not apply.
- 16. Regulation 84 of Table A, Part I, shall not apply. Any director or any company or firm of which a director is a member may enter into contracts with the Company and any director may vote as director or shareholder in respect of such contract and retain for his own use profits made by him under any such contract; provided always that unless he is at the time sole director he must disclose his interest to his co-directors before the contract is entered into and if he is at the time sole director, or if all the directors are interested in the contract, the contract must be entered into by the Company in general meeting, and before any contract is entered into the director or directors must disclose his or their interest to the meeting. A general notice to the directors given at a meeting of the directors by any director to the effect that he is a member of any specified company or firm and is to be regarded as interested in any contract which may thereafter be made with that company or firm shall be deemed a sufficient disclosure of interest in regard to any contract so made.
- 17. No director shall at any time be required to retire or vacate his office of director or be ineligible for reappointment as director by reason of his attaining or having attained the age of 70 or any other age, and Regulation 88 of Table A, Part I, shall in its application to the Company be modified accordingly.
- 18. In Regulation 5 of Table A, Part II, for the words "all the members for the time being entitled to receive notice of and to attend and vote at General Meetings" there shall be substituted the words "the holders of three-fourths of the issued shares of the Company".
