ORDER

UPON the Application of the Applicant dated 24 May 2019 ("the Application")

AND UPON READING the evidence

AND UPON HEARING Carly Sandbach of Counsel for the Applicant

AND UPON the Court noting that the statement of intention on the part of the Applicant set out in the email from Mark Hague to Laura Holmes of 16:55 on 23 May 2019

IT IS ORDERED that:

1. Each of the County Court cases listed in the Schedule (attached hereto) be transferred to the High Court of Justice, Business & Property Courts in Manchester, Insolvency & Companies List (ChD) for the purpose of the determination and disposal of this Application.
2. Immediately upon this order being made, the County Court cases listed in the Schedule (attached hereto) be transferred back to the County Court from which they were transferred.
3. The Applicant, be removed from his office as one of the joint administrators in respect of the companies in administration which are set out in Schedules A1, A2 and A3 attached hereto.
4. The First Respondent, Julien Robert Irving, shall be appointed as one of the joint administrators of the companies in administration listed in Schedule A1 in place of the Applicant.
5. The Second Respondent, Megan Singleton, shall be appointed as one of the joint administrators of the companies in administration listed in Schedule A2 in place of the Applicant.
6. The Third Respondent, Andrew Poxon, shall be appointed as one of the joint administrators of the companies in administration listed in Schedule A3 in place of the Applicant.
7. The Applicant, be removed from his office as trustee in bankruptcy of the bankruptcy estates described in Schedule B.
8. The Fourth Respondent, Amy Mehers, shall be appointed as trustee in bankruptcy of the estates listed in Schedule B in place of the Applicant.
9. The Applicant, be removed from his office as one of the joint liquidators of the companies in compulsory liquidation listed in Schedule C1, C2 and C3.
10. The Fourth Respondent, Amy Mehers, shall be appointed as one of the joint liquidators of the companies in compulsory liquidation listed in Schedule C1 in place of the Applicant.
11. The First Respondent, Julien Robert Irving, shall be appointed as one of the joint liquidators of the companies in compulsory liquidation listed in Schedule C2 in place of the Applicant.

12. The Third Respondent, Andrew Poxon, shall be appointed as one of the joint liquidators of the companies in compulsory liquidation listed in Schedule C3 in place of the Applicant.
13. The Applicant, be removed from his office as one of the joint supervisors of the company voluntary arrangements listed in Schedule D1 and D2.
14. The Fifth Respondent, Martin Maloney, shall be appointed as one of the joint supervisors of the company voluntary arrangements listed in Schedule D1 in place of the Applicant.
15. The Third Respondent, Andrew Poxon, shall be appointed as one of the joint supervisors of the company voluntary arrangements listed in Schedule D2 in place of the Applicant.
16. The Applicant be removed from his office as one of the joint liquidators of the companies in creditors' voluntary liquidation listed in Schedules E1, E2, E3, E4, E5 and E6.
17. The Fifth Respondent, Martin Maloney, shall be appointed as one of the joint liquidators of the companies in creditors' voluntary liquidation listed in Schedule E1 in place of the Applicant.
18. The First Respondent, Julien Robert Irving, shall be appointed as one of the joint liquidators of the companies in creditors' voluntary liquidation listed in Schedule E2 in place of the Applicant.
19. The Third Respondent, Andrew Poxon, shall be appointed as one of the joint liquidators of the companies in creditors' voluntary liquidation listed in Schedule E3 in place of the Applicant.
20. The Second Respondent, Megan Singleton, shall be appointed as one of the joint liquidators of the companies in creditors' voluntary liquidation listed in Schedule E4 in place of the Applicant.
21. The Sixth Respondent, Steve Markey, shall be appointed as one of the joint liquidators of the companies in creditors' voluntary liquidation listed in Schedule E5 in place of the Applicant.
22. The Seventh Respondent, Lisa Ion, shall be appointed as one of the joint liquidators of the companies in creditors' voluntary liquidation listed in Schedule E6 in place of the Applicant.
23. The Applicant be removed from his office as one of the joint liquidators of the companies in members' voluntary liquidation listed in Schedule F1 and F2.
24. The Sixth Respondent, Steve Markey, shall be appointed as one of the joint liquidators of the company in members' voluntary liquidation listed in Schedule F1 in place of the Applicant.

25. The Seventh Respondent, Lisa Ion, shall be appointed as one of the joint liquidators of the companies in members' voluntary liquidation listed in Schedule F2 in place of the Applicant.
26. The creditors and members in each of the block transfer cases listed in the Schedule be notified of this order by the Applicant placing notice of it in the London Gazette within 28 days of the date of this order.
27. Any creditor, or, in the case of any members' voluntary liquidation, any member, in respect of any of the companies or persons listed in the Schedule who has an objection to this order shall have 28 days from the date of the advertisement to apply to court to set aside or vary the terms of this order. Such application shall not affect the transfer of the block transfer cases the Schedule until further or other order by the court.
28. The replacement officeholders do file any appropriate notices in respect of the removal of the Applicant and the appointment of the replacement officeholders with the Secretary of State for Business, Energy & Industrial Strategy (Insolvency Service) and the Registrar of Companies as may be required.
29. The Applicant shall file a copy of this order with each of the courts listed in Schedule B which relate to bankruptcy cases.
30. Nothing in this order shall release the Applicant from any obligation to give and file notices in respect of his removal under this order in respect of the block transfer cases listed in the Schedule.
31. The Applicant shall have his release and be discharged from liability as officeholder in respect of all the Appointments in the Schedule hereto, 28 days after the publication of a Notice in the Gazette as provided for by paragraph 26 of this Order.
32. The costs of this application shall be paid as an expense and shall be apportioned equally between each of the block transfer cases so that the estate of each block transfer case shall bear an equal proportion of the costs.
