(A) immediately upon restoration of the name of the Company to the Register of Companies inform the Registrar of Companies of the title and Court reference number of the proposed litigation referred to in paragraph 3 of the Witness Statement of Maria Pilkington dated the 19<sup>th</sup> February 2015 immediately after issue

AND UPON the solicitors for the Claimant and for the Registrar of Companies
(the Defendant) both consenting to this Order

#### IT IS ORDERED THAT:

- (1) the name of the above named Power Centre Limited be restored to the Register of Companies
- (2) If at the date of registration of this Order with the Registrar of Companies the name of the Company is not available the Registrar of Companies shall pursuant to Section 1033(2)(a)(ii) and (b) of the Companies Act 2006 change the name of the Company to 02235556 Limited
- (3) an Office Copy of the Order be delivered to the Registrar of
  Companies and pursuant to the above mentioned Act the
  Company is thereupon to be deemed to have continued in
  existence as if its name had not been struck off



- (4) the Registrar-of Companies do advertise notice of this Order in his official name in the "London Gazette"
- (5) the Claimant do pay to the Registrar of Companies his costs of the said Application in the agreed sum of £300-00
- (6) in the event that the Claimant falls to comply with undertaking (C) above the Registrar of Companies be at liberty to commence strike off action in respect of the Company without further notice to the Claimant



(7) the hearing fixed for the 5th June 2015 be vacated
