

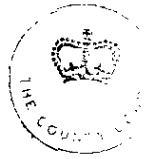

AND UPON READING the evidence

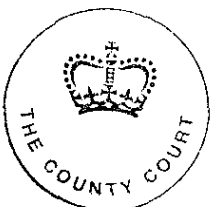
AND IT APPEARING that there is no opposition on behalf of Her Majesty in
