**UPON the application of the applicant**

**AND UPON reading the evidence**

**IT IS ORDERED THAT:**

1. Any of the cases listed in the schedules attached to this Order which are proceeding in the County Court are transferred to the High Court (Bristol District Registry) solely for the purpose of this Order and thereafter are transferred back to the original Court.
2. Any of the cases listed in the schedules attached to this Order which are proceeding in the High Court (Royal Courts of Justice) or in a District Registry (other than Bristol District Registry) are transferred to the High Court (Bristol District Registry) Solely for the purposes of this Order and thereafter are transferred back to the original Court.

3. Pursuant to section 303(2) of the insolvency Act 1986 Jeremy Willmont is appointed as a joint trustee in bankruptcy of the individuals listed in Schedule A attached to this Order with immediate effect.
