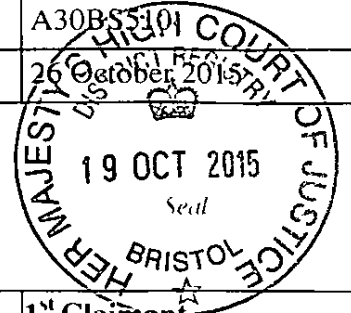

AND IT APPEARING that there is no opposition on behalf of Her Majesty to the relief sought by this claim as appears from the Evidence of Service of Crispin John Boyce and the exhibit thereto

AND the Claimant by its solicitors undertaking that

- (A) The company will not carry on business or operate in any way other than to take the necessary steps to receive and distribute a compensation payment from HSBC Bank PLC in relation to interest rate Hedging Products referred to in paragraph 9 of the Witness Statement of Stephen Mark Perry dated the 17 September 2014 (the action), according to law
- (B) he will notify the Registrar of Companies immediately on the conclusion of the action
- (C) The director of the company will immediately on the expiry of 3 months from the conclusion of the action apply to the Registrar of Companies for the voluntary strike off of the company under Section 1003 of the Companies Act 2006 and comply with all the relevant requirements for such an application
- (D) he will unless the action is completed in the interim, at 6 monthly intervals from the date of the Order serve on the Registrar of Companies a full and sufficient Witness Statement setting out what steps have been taken to progress the action

AND UPON the solicitors for the Claimant and the Registrar of Companies (the Defendant) both consenting to this Order
