Structure, Governance and Management

Governing document

The Company is limited by guarantee and has no issued share capital. It is a registered charity, and its governing instruments are its Memorandum and Articles of Association. The liability of its members shall not exceed £1.

Organisational structure

The Board of Trustees/Directors is wholly responsible for policy direction, decision making and allocation of funds. The Company has no premises, equipment or employees. The Trustees/Directors are aware of the Charity Commission's guidance on public benefit and have and will continue to give attention to it in their administration of the Charity. It is considered that the Trustees/Directors of the Charity are deemed to be 'fit and proper' persons in accordance with the Finance Act 2010.

Related parties

Currently the Company has no related parties.

Risk management

The Trustees/Directors accept they have a duty to identify and review the risks to which the Company is exposed and again confirm that appropriate controls are in place to provide reasonable assurance against fraud and error.

Recruitment of Board Members

Recruitment to the Board is by nomination by a current or retiring Board Member only. Having completed a Nomination form the prospective member is invited as an observer to a Board meeting when the charity's Objectives and Aims are explained and any questions answered. Subject to agreement by both parties the prospective member completes an Appointment form declaring, inter alia, a willingness to act as a trustee, that s/he is of good character, has no criminal convictions and there are no matters which would prevent acting as a charity trustee by virtue of section 178 of the Charities Act 2011. Following appointment at the next Board meeting or AGM, induction is completed by way of receiving a copy of the Memorandum & Articles of Association and relevant leaflets.

Objectives and Activities

Objectives and aims

The relief of poverty amongst young people aged 16 - 25 years who are homeless or threatened with homelessness in Lancashire and who are in need, hardship and distress, particularly by working through partnership by providing household equipment, bedding, personal items and presents, funding outings and also activities which will be of benefit to them currently or later in life.

Grantmaking

The Company does not make grants as such but reimburses the organisation supplying the benefit to or for young people.

Achievement and Performance

Volunteer's contributions

There are no volunteers other than the Board Members.

Principal Sources of funds

Other than investment interest The Harris Charity, The Santander Foundation, Unite and The Yorkshire Building Society were the sources of funds received during the financial year to 31st March 2016.

Directors expenses

Expenses totalling £120 were claimed by one Director in the financial year in respect of travel to meetings and Expense claims by any of the Directors must be approved by the Chair whose own claim sundry expenses. would be approved jointly by the Treasurer (who is also a Director) and a second Director and listed separately in the accounts.

Financial Review

Reserves policy The Company's policy is to retain funds equal to approximately three month's average expenditure.

Funds in deficit

The Charity has remained solvent since incorporation.

Gift Aid

Donations by Gift Aid and tax reclaimed will be treated as unrestricted income unless directed otherwise by the donor.

Investment policy and objectives

Funds surplus to immediate requirement are invested in a deposit account with CAF Bank Limited with interest derived classified as unrestricted income.

Review of the year's activities including future plans

The upheaval in Supporting People early in 2015 whereby contracts were terminated and new contracts commenced resulted in an immediate significant fall in requests for funding a range of household items for young people to the extent that some funding was recalled by the donor when it had become apparent the funds were unlikely to be used by the end date specified. Several organisations were approached and funding offered but without success resulting in the Trustees considering whether there was any future for the charity.

Towards the end of 2015, however there was an increase in requests for funds as new arrangements settled down but by which time it was necessary to seek an extension to the end dates in respect of two remaining Accordingly, the Trustees wish to record their appreciation to The Santander Foundation and The Harris Charity for agreeing to such extensions. In view therefore of the surprising lack of interest the Trustees have decided to exhaust existing funds unless recalled earlier and not to seek any new partner organisations or additional funds pending a final decision on the charity's future.

A total of 36 young people benefited during the financial year by the provision through partnership of essential This figure compares unfavourably with the 89 young people who benefited in the household items. previous financial year reflecting the lack of requests in the first six months.

Independent Examiner's Report to the Trustees of the Lancashire Young Homeless Project Limited

I report on the accounts of the company for the year ended 31st March 2016, which are set out on pages 5 to 10.

Respective responsibilities of trustees and examiner

The trustees (who are also the directors of the charity for the purposes of company law) are responsible for the preparation of the accounts. The trustees consider that an audit is not required for the year under section 144(2) of the Charities Act 2011 (the 2011 Act) and that an independent examination is needed.

It also includes consideration of any unusual items or disclosures in the accounts, and seeking explanations from you as trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit and consequently no opinion is given as to whether the accounts present a 'true and fair view' and the report is limited to those matters set out in the statement below.

Notes to the Financial Statements for the year ended 31st March 2016

1. Accounting Policies

Accounting convention

The financial statements have been prepared under the historic cost convention, and in accordance with the Financial Reporting Standard for Small entities (effective April 2008), the Companies Act 2006 and the requirements of the Statement of Recommended Practice, Accounting and Reporting by Charities.

Incoming resources

All incoming resources are included on the Statement of Financial Activities when the charity is legally entitled to the income and the amount can be quantified with reasonable accuracy.

Resources expended

Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all costs related to the category. Where costs have been directly attributed to particular headings they have been allocated to activities on a consistent basis with the use of resources.

Investment income

Investment income is accountable on a receivable basis.

Value Added Tax

As the majority of the Lancashire's Young Homeless Project Limited's activities are classified as exempt or non-business activities for the purpose of value added tax, Lancashire Young Homeless Project Limited is unable to reclaim any of the value added tax which it suffers on its purchases. Expenditure in these financial statements is therefore shown inclusive of value added tax.

Taxation

The charity is exempt from corporation tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restrictive purposes within the objects of the charity.

Restrictions arise when specified by the donor or when funds are raised for a particular restricted purpose.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.
