## Strategic report

The Directors present their Strategic report, their Directors' report and the financial statements for the year ended 31 January 2019.

#### Principal activities and review of the business

The principal activity of the Company is to act as a holding company.

There has been no income statement activity in the year.

#### Principal risks and uncertainties

There is a liquidity risk if the investments underperform and do not provide sufficient dividends to cover the Company's short term liabilities as they fall due. The company therefore relies upon the ongoing support of its ultimate parent company, Tech Data Corporation.

There is a risk that if the value of underlying investments falls below carrying value that these assets may be impaired, resulting in a charge through the Income Statement.

There is also a foreign currency risk as a significant proportion of the subsidiaries' trade is in currencies other than GBP, therefore should exchange rates move adversely, the GBP value of any dividend income may be affected.

The Company's ultimate parent company, Tech Data Corporation, has confirmed that it will provide financial support to the Company to meet its liabilities as and when they fall due. The directors therefore consider that it is appropriate to draw up these accounts on a going concern basis.

The potential risks arising as a result of the United Kingdom leaving the European Union at a future date cannot currently be quantified due to the level of uncertainty inherent in the process.

## **Future developments**

The directors expect the Company to continue as an intermediate holding company for the foreseeable future.

#### Notes to the financial Statements

#### 1 Authorisation of Financial Statements and Statement of compliance with FRS101

#### Statement of compliance:

The financial statements for the year ended 31st January 2019 were prepared in accordance with Financial Reporting Standard 101 Reduced Disclosure Framework.

The Company is exempt from the requirement to prepare consolidated financial statements, on the grounds that it is a wholly-owned subsidiary of Tech Data Corporation, incorporated in the USA, whose consolidated accounts are publicly available and are prepared on an equivalent basis (see note 9).

#### 2 Accounting policies

#### 2.1 Basis of preparation

The financial statements are prepared under the historical cost convention and in accordance with applicable accounting standards.

The Company has taken advantage of the following disclosure exemptions under FRS 101:

- a) The requirements of IFRS 7 Financial Instruments: Disclosures;
- b) The requirements of IAS 7 Statement of Cash Flows;
- c) The requirements of paragraph 17 of IAS 24 Related Party Disclosures;
- d) The requirement of IAS 8 in regards to standards issued but not effective;
- e) The requirements under IFRS13 in regards to fair value disclosures; and
- f) The requirements of paragraphs 130(f)(ii), 130(f)(iii), 134(d)-134(f) and 135(c)-135(e) of IAS 36 Impairment of Assets.

The Company applied for the first time certain amendments to the standards, which are effective for annual periods beginning on or after 1 January 2018. The company has not early adopted any standards, interpretations or amendments that have been issued but are not yet effective. The nature and the impact of each amendment is described below:

#### IFRS 9 Financial Instruments

IFRS 9 Financial Instruments replaces IAS 39 Financial Instruments: Recognition and Measurement for annual periods beginning on or after 1 January 2018, bringing together all three aspects of the accounting for financial instruments: classification and measurement; impairment; and hedge accounting. The application of IFRS 9 has not led to any material adjustments to the financial statements for either the current or prior year and therefore no disclosures on the effect of the adoption of IFRS 9 are provided.

#### Impairment of non-financial assets

The Company assesses at each reporting date whether there is an indication that an asset may be impaired. If any such indication exists, or when annual impairment testing for an asset is required, the Company makes an estimate of the asset's recoverable amount in order to determine the extent of the impairment loss. An asset's recoverable amount is the higher of an asset's or cash-generating unit's fair value less costs to sell and its value in use and is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets. Where the carrying amount of an asset exceeds its recoverable amount, the asset is considered impaired and is written down to its recoverable amount. Impairment losses on continuing operations are recognised in the income statement in those expense categories consistent with the function of the impaired asset. For assets where an impairment loss subsequently reverses, the carrying amount of the asset or cash generating unit is increased to the revised estimate of its recoverable amount, not to exceed the carrying amount that would have been determined, net of depreciation, had no impairment losses been recognised for the asset or cash generating unit in prior years. A reversal of impairment loss is recognised immediately in the income statement, unless the asset is carried at a revalued amount when it is treated as a revaluation increase.

#### 2 Accounting policies (continued)

#### 2.1 Basis of preparation (continued)

The financial statements present the information about the entity as an individual and not as a group. Azlan Group Limited is a limited liability company and is incorporated in England. The company's financial statements are presented in Sterling and are rounded to the nearest million except where otherwise indicated. The functional currency is GBP.

#### Going Concern

The ultimate parent company (Tech Data Corporation) has confirmed that it will provide financial support for a period at least until 31 October 2020. The Directors therefore consider that it is appropriate to draw up these accounts on a going concern basis.

#### 2.2 Judgements and Key Sources of estimation uncertainty

#### **Impairment**

Investments are assessed at each reporting date for impairment through a review of impairment indicators. Given the non-trading (holding company) nature of the investments in Tech Data (Netherlands) B.V., Azlan GmbH and ManeBoard Limited, a key indicator is the underlying net assets of these subsidiaries. Where the carrying amount of the investment exceeds the underlying net assets of a subsidiary, this is an indicator of impairment. An impairment test is then performed based on the recoverable amount as defined by IAS 36. Impairment charges, where the carrying value of the investment exceeds its recoverable amount, are recognised in the Income Statement.

#### 2.3 Significant Accounting Policies

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the Company's financial statements.

#### Investments

Investments in subsidiaries are held at historical cost less any applicable provision for impairment.

#### Foreign currencies

Assets and liabilities expressed in foreign currencies are translated into GBP at the rates ruling at the Statement of Financial Position date. Transactions expressed in foreign currencies are translated into GBP at the rates ruling at the transaction date. Exchange gains and losses arising are recognised in the Income Statement.

#### Taxation

Current tax assets and liabilities are measured at the amount expected to be recovered from or paid to the tax authorities, based on the tax rates and laws that are enacted or substantively enacted by the period end date.

Income tax is charged or credited to Other Comprehensive Income if it relates to items that are charged or credited to Other Comprehensive Income. Similarly, income tax is charged or credited directly to Equity. Otherwise income tax is recognised in the Income Statement.

#### Dividend income

Dividend income is recognised when the Company's right to receive payment is established. Any income that is not settled in the period is included with inter-company debtors at the balance sheet date.

#### 2 Accounting policies (continued)

## 2.3 Significant Accounting Policies (continued)

#### Intercompany receivables

Intercompany receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market. Intercompany receivables are recognised initially at fair value and subsequently measured at amortised cost using the effective interest method.

The Intercompany balances have not been reviewed as a part of IFRS 9 changes as all inter-company payables and receivables are with wholly owned fellow group companies and therefore the Company has no risk against these balances.

#### Intercompany payables

Intercompany payables are non-derivative financial liabilities with fixed or determinable payments that are not quoted in an active market. These are recognised initially at fair value and subsequently measured at amortised cost using the effective interest method.

#### 3 Directors' remuneration

The directors received remuneration for the period estimated at £5,000 each (2018: £5,000) in relation to qualifying services as a director of this Company, all of which was borne by other group companies.

#### 4 Audit fees

Fees of £8,000 (2018: £8,000) were paid by another group company to the auditors in respect of the audit of the Company's financial statements
