2. Receipts and Payments

3. Work Undertaken by the Liquidators since appointment

- Preparing and submitting various statutory notices and letters, including advertising in the London Gazette and filings with the Registrar;
- Undertaking periodic case progression reviews;
- Dealing with pre and post-liquidation tax and VAT matters including obtaining the relevant clearances from HM Revenue & Customs; and
- · Compliance with all liquidation statutory requirements and internal procedures; and
- Liaising with the Company's shareholder and their advisors regarding finalisation of liquidation affairs.

4. Dividend to Creditors

Preferential Creditors

There are no preferential creditors in this matter.

Unsecured Creditors

Formal notice for all creditors to submit claims was advertised in the London Gazette following my appointment as Liquidator.

No claims were received.

5. Distribution to Shareholders

A distribution in specie of the Company's share capital of £1, being a distribution of £1 per ordinary £1 share, was made to the Company's shareholder, Systems Union Group Limited, on 3 December 2019.

No further distributions will be made.

6. Liquidators' Remuneration, Disbursements and Expenses

Liquidators' Remuneration

The members passed a resolution that the Liquidators' remuneration should be calculated on a time cost basis, estimated at £20,000, plus VAT, for the group of nine companies. I have therefore split the costs equally between the companies and estimate the costs of each company at £2,222, plus VAT.

A breakdown of my firm's time costs incurred during the Period is attached at **Appendix B.** You will note that the time costs for this case are £1,899. This takes into account the final costs to close the liquidation.

The fee was paid by an associated company, Infor (Midlands II) Limited and as the funds did not come into the liquidation, they have not been reflected on the receipts and payments account.

Liquidators' Disbursements

The Liquidators' disbursements are a recharge of actual costs incurred by the Liquidators in dealing with this matter. Mileage payments made for expenses relating to the use of private vehicles for business travel, which is directly attributable to the insolvency estate, are paid by FRP Advisory at the HMRC approved mileage rate prevailing at the time the mileage was incurred. Details of disbursements incurred during the Period are set out in **Appendix B**.

Expenses of the Liquidation

I attach at **Appendix C** a Statement of Expenses that have been incurred during the Period.

Members' Rights

Members have a right to request further information from the Liquidators and further have a right to challenge the Liquidators' remuneration and other expenses, which are first disclosed in this report, under the Insolvency Rules.
