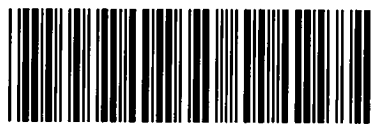

#### 1 Average employees


