

Principal Activity

The Company is a guarantee company set up to administer the running and up-keep of the sewerage system serving the members of the Company.

Members of the Company must be current occupiers of a dwelling benefitting from the use of the sewerage system. The current number of members is 15. Members' liability is £1.00 each.

Review of Business

During the year a **surplus** income over expenditure of **£1638.00** was produced and this sum is held in current and deposit accounts at Lloyds Bank and Barclays Bank. This small reserve is to be used to offset future maintenance costs as agreed and directed by the Board of Members.

Responsibilities of the Directors

The Directors are required by the UK Company law to prepare an end of year financial statements that is a true and fair analysis of the Company's state of the affairs.

The Directors confirm that suitable accounting policies have been used and applied consistently in the preparation of the financial statements for **year ended 31st August 2017**.
