 - To enter into guarantees, contracts of indemnity and suretyships of all kinds and to guarantee, grant indemnities in respect of or otherwise support or secure, whether by personal covenant or by mortgage, charge, standard security, lien or other security upon all or any part of the undertaking, property, assets, rights and revenues present or future and the uncalled capital of the Company, or by the creation and/or issue at par or at a premium or discount and with or without consideration and with such rights, powers and privileges and on such other terms (including without limitation as permanent, redeemable or repayable) as may be thought fit of debentures or debenture stock or securities of any other description or by any one or more of such methods or by any other means whatsoever, the liabilities and obligations of and the payment of any moneys whatsoever (including but not limited to principal, interest and other liabilities of any borrowings or acceptance credits and capital, premiums, dividends, costs and expenses of any stock, shares or securities) by any person, firm or company (whether or not any such person firm or company has objects or engages or is intending to engage in businesses similar to those of the Company) including without limitation any company which is for the time being the holding company or a subsidiary (both as defined as section 736 of the Companies Act 1985) of the Company or of any holding company of the Company or which is otherwise associated in any way with the Company.
