ORDER

---

UPON the application of Francis Gavin Savage

AND UPON reading the evidence

AND UPON the Court being satisfied that it is entitled to determine the application without a hearing pursuant to Rule 12.12 (c) of the Insolvency Rules 2016

IT IS ORDERED THAT:-

1. Pursuant to Rule 12.30 of the Insolvency 2016 ("the Rules") any of the matters listed in the Schedules to this Statement and which are proceeding in any court other than the High Court are transferred to the High Court solely for the purposes of this Order.
2. Pursuant to Rule 12.37 (2) of the Rules, the Applicant be removed from his office as liquidator, administrator, supervisor or trustee in bankruptcy of the matters listed in Schedules 1 to 10 attached to this Statement with immediate effect.
3. Pursuant to Rule 12.37 (3) of the Rules, Sally Richards be appointed as joint liquidator, joint supervisor, joint trustee in bankruptcy and/or joint administrator of the matters listed in Schedules 1 and 2B attached to this Statement with immediate effect.
4. Pursuant to Rule 12.37 (3) of the Rules, Julie Anne Palmer be appointed as joint trustee in bankruptcy, joint liquidator and joint administrator of the matters listed in Schedule 2A attached to this Statement with immediate effect.
5. Pursuant to Rule 12.37 (3) of the Rules, Julie Anne Palmer be appointed as sole trustee in bankruptcy of the matters listed in Schedule 3 attached to this Statement with immediate effect.
6. Pursuant to Rule 12.37 (3) of the Rules, Julie Anne Palmer be appointed as joint liquidator of the companies listed in Schedule 4 attached to this Statement with immediate effect.
7. Pursuant to Rule 12.37 (3) of the Rules, Julie Anne Palmer be appointed as joint administrator of Fleetstyle Distribution Limited as listed in Schedule 5 attached to this Statement with immediate effect.
8. Pursuant to Rule 12.37 (3) of the Rules, Julie Anne Palmer be appointed as joint trustee of the bankruptcy estate of Joyce Rennie-Pascall as listed in Schedule 6 attached to this Statement with immediate effect.
9. Pursuant to Rule 12.37 (3) of the Rules, Julie Anne Palmer be appointed as joint liquidator of Lisa Furness Ltd as listed in Schedule 7 Statement to this application with immediate effect.

14. In respect of any existing court applications or proceedings arising out of any of the matters listed in Schedules 1 to 10 attached to this statement, the replacement officeholder(s) shall be substituted for the Applicant by virtue of this Order.
15. Where required any relevant notice required to be filed at Court be filed at the same time as the next notification as required pursuant to statute.
16. The appointments made pursuant to this application shall be notified to the creditors at the same time as the next report pursuant to statute is made to the creditors. Such notice shall

include an explanation as to the effect of the Order and express reference to the liberty to apply as set out in the Order.

17. Liberty to each creditor of each bankruptcy and liquidation to apply to vary or discharge the Order within 28 days of receipt of the notices referred to in paragraph 16 above.
18. The costs of this application shall be borne as an expense of the cases in the Schedules attached. The costs allocated to each case shall not exceed 10% of the realisations in that case.
19. Pursuant to Rule 12.30 of the Rules, any of the matters transferred to the High Court pursuant to paragraph 1 above, shall be transferred back to the Court or hearing centre listed in Schedules 1 to 10 attached to this application.
20. Such other directions as the court sees fit.
