COMPANIES HOUSE

1. in respect of the company voluntary arrangement, administration, compulsory liquidation, individual voluntary arrangement, and bankruptcy appointments identified in the Schedule to this Order ("the Schedule") as being the subject of proceedings in the various County Courts specified in the Schedule, those proceedings be transferred to The High Court, Chancery Division, solely for the purpose of making the orders contained in the paragraphs below.
2. The following removals and appointments take place:-
  - (i) In relation to all the company voluntary arrangement appointments held by the First Respondent solely and jointly with others, the First Respondent be removed from office and the First, Second and Third Applicants be appointed in his place, as detailed in the Schedule.
  - (ii) In relation to all the members' voluntary liquidation, administration, creditors' voluntary liquidation and compulsory liquidation appointments held by the First Respondent solely and jointly, the First Respondent be removed from office and the First, Second and Third Applicants be appointed in his place or in certain of the cases the Fourth Applicant continues to act solely, as detailed in the Schedule.
  - (iii) In relation to all the individual voluntary arrangement appointments held by the First Respondent solely and jointly, the First Respondent be removed from office and the Fourth and Sixth Applicants be appointed in his place or in certain of the cases the Fourth Applicant continues to act solely, as detailed in the Schedule.
  - (iv) In relation to all bankruptcy appointments held by the First Respondent, the First Respondent be removed from office and the First, Second, Third and Fifth Applicants be appointed in his place or in certain of the cases the Third Applicant continues to act solely, as detailed in the Schedule.
  - (v) The effect of these orders is as summarised by reference to the initials of the incoming and outgoing office holders set out in the schedule annexed hereto.
3. The Applicants shall at the first opportunity to do so, and in any event within 3 months of the date of this Order, publish in the London Gazette one composite notice in relation to each of the estates containing notification of the following matters:
  - (i) the removal of the First Respondent and the appointment of his replacement/s,
  - (ii) that creditors/members have liberty to apply, within 28 days of the date of the advertisement, to vary or discharge the Order made,
  - (iii) where a liquidation committee has been appointed, an explanation that it is open to the committee to require the Applicants appointed or remaining in office to provide an account of the administration of the winding up pursuant to IR 4.108(3), including:
    - (a) a summary of receipts and payments;
    - (b) a statement that he has reconciled his accounts.
  - (iv) where no liquidation committee has been appointed, an explanation that it is open to any creditor of a liquidation in the Schedule to apply for an order that the Applicants in question do provide such information as they might otherwise be required by IR 4.108(3), that is to say an account of the administration of the winding up, including:
    - (a) a summary of receipts and payments;
    - (b) a statement that he has reconciled his accounts.

(v) notification that if the Applicants in question have been required to provide the information referred to in paragraphs 3(iii) or 3(iv) above whether by creditors' committee or on the application of any individual creditor, the Applicants' costs of complying with such request or order shall, unless good reasons to the contrary are demonstrated, be paid as costs of the winding up.

(vi) in the case of each bankruptcy and liquidation that:

- (a) the creditors have the right to object and make representations to the Secretary of State in respect of the First Respondent's release within 28 days of the date of the advertisement
- (b) the First Respondent will be entitled to apply to the Secretary of State for his release 42 days after the date of the advertisement

No further advertisement concerning the removal of the First Respondent and the appointment of the Applicants is required, save for the circulation referred to in paragraph 4 below.

4. The Applicants shall when the next report is due to the creditors/members of each company voluntary arrangement, members' voluntary liquidation, administration, creditors' voluntary liquidation, compulsory liquidation, individual voluntary arrangement or bankruptcy give notice of the making of this Order to each such creditor of each company voluntary arrangement, members' voluntary liquidation, administration, creditors' voluntary liquidation, compulsory liquidation, individual voluntary arrangement or bankruptcy such notice to include the date of the Order, the fact of the removal of the First Respondent and the appointment of his replacement/s.
5. Liberty to each creditor/member of each liquidation, company voluntary arrangement, administration, bankruptcy and individual voluntary arrangement to apply to vary or discharge this Order within 28 days of the date of the advertisement in the London Gazette.
6. the First Respondent be released from all liability in respect of his acts and omissions and in relation to his conduct as office holder whilst acting as Administrator in respect of the companies listed in Administration in the attached Schedule, with effect from 31 days after circulation of each report respectively referred to in paragraph 4 above, save in respect of any claim notified to the First Respondent or (where appropriate) his joint appointee or replacement office holder by that date pursuant to the Act and/or pursuant to such other provisions as may apply.
7. The First Respondent shall not be at liberty to apply to the Secretary of State for his release from his position as liquidator (whether voluntary or compulsory) or as trustee in bankruptcy until after the expiry of 42 days from the circulation of each report respectively referred to in paragraph 4 above.
8. That the costs of this application be apportioned as follows:-
  - (a) such remuneration, costs or expenses in respect of this Application as are referable to a particular matter in the Schedule shall be fixed and paid in the ordinary way as remuneration, costs or expenses in respect of such matter; and
  - (b) such remuneration, costs or expenses in respect of this Application as are not referable to a particular matter shall be divided equally between each of the estates identified in the Schedule and thereafter treated as costs or expenses of such estates;

PROVIDED THAT in no case shall the total of such remuneration, costs and expenses (including VAT) payable under (a) and (b) above exceed 10% of the value of the realised assets in that particular matter.
