**IT IS ORDERED THAT:-**

1. The matters listed in Appendix A to this application be transferred to the High Court for the purpose of this application only pursuant to Rule 7.11(4A) of the Rules;
2. The Applicant be and is hereby removed as officeholder in relation to all those matters listed in Appendix A in which the Applicant held sole office and that the First Respondent be appointed as the sole office-holder in place of the Applicant in relation to those matters;
3. The Applicant and the Second Respondent be and are hereby removed as officeholders in relation to all those matters listed in Appendix A in which the Applicant and the Second Respondent held joint office and that the First Respondent be appointed as the sole office-holder in place of the Applicant and the Second Respondent in relation to those matter;
4. The matters listed in Appendix A be transferred back to the court from which they were transferred
5. The First Respondent shall at the first opportunity and in any event within 3 months of the date hereof, give notice of this Order, either by letter or by advertisement in the Gazette to all creditors of the matters listed in Appendix A, the Secretary of State and the Registrar of Companies
6. The First Respondent shall at the first opportunity and in any event within 3 months of the date of this Order lodge a sealed copy of this Order at any District Registry or County Court where a case listed in Appendix A is pending

7 The creditors of any matter identified in Appendix A do have liberty to apply to this Court within 28 days of notice of this Order having been given in accordance with paragraph 5 above

8 The provisions contained in the Rules in relation to the reporting requirements of the Applicant and the Respondent upon them vacating office in relation to the insolvency appointments listed in Appendix A shall not apply and neither the Applicant or the second Respondent is required to produce any progress reports on ceasing to act as office holder pursuant to this Order.

9. Pursuant to Rule 12A.55 of the Rules and rule 3.1(2)(a) of the Civil Procedure Rules 1998 (as amended) and in respect of each case listed in Appendix A the time by which progress reports are required to be delivered by the First Respondent pursuant to the Rules and/or the Act following this Order be extended or shortened as is applicable to the date on which such progress reports would have been required in each matter had this Order not been made.
