Dormant companies acting as an agent for any person must state that they have so acted in Section 3. d. A fee or penalty raised on the company for the payment of an annual return fee, change of name fee, reregistration fee, or late filling penalty may be omitted from the company records and this DCA—if the payment was made by a third party without any right of reimbursement. e. The company directors are responsible for preparing and filling accounts at Companies House that comply with the requirements of the Companies Act and failure to do so may result in prosecution.
