NOTE TO THE FINANCIAL STATEMENTS

1. DIRECTOR'S ADVANCES, CREDITS AND GUARANTEES

At the start of the year Mr H Parvarandeh had an overdrawn loan account balance of £30,278. During the year he was advanced £15,396, and credited £35,603, leaving an overdrawn balance of £10,071 at the year end.

The company is entitled to exemption from audit under Section 477 of the Companies Act 2006 for the year ended 31 March 2017.
