**1. OTHER FINANCIAL COMMITMENTS**

Operating lease commitments on the remaining lease term amounted to £1,671 at the year end.  
The lease was renewed from June 2017 at an increased rental for a further 10 years.

Creditors include an interest free loan of £25,000 which is secured on the freehold land.

The company is entitled to exemption from audit under Section 477 of the Companies Act 2006 for the year ended 31 March 2017.

The members have not required the company to obtain an audit of its financial statements for the year ended 31 March 2017 in accordance with Section 476 of the Companies Act 2006.
