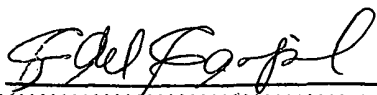
Principal activity

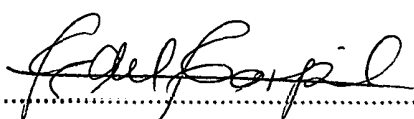
