

This is the Liquidator's first progress report ("the report") for the period from appointment on 11 January 2018 to 10 January 2019.

1. Statutory information

The Company was wound up in the High Court of Justice on 10 July 2017 following the filing of a petition on 28 May 2017 by H M Revenue & Customs ("HMRC").

The Company's registered name is McGuire Support Services Limited and it traded in construction activities.

The Company was incorporated on 6 May 2011 under company number 07625441 and the registered office was at 7 St Johns Road, Harrow, Middlesex, HA1 2EY.

I, John Edmund Paylor of Guardian Business Recovery, 72 Temple Chambers, Temple Avenue, London EC4Y 0HP was appointed Liquidator of the above-named Company by the Secretary of State on 11 January 2018.

There have been no changes of Liquidator in the period to which this report relates.

2. Liquidator's remuneration

I would advise that no resolution has been sought from creditors regarding my remuneration up to date.

During the period under review, the actual charge out value of my firm's time costs in attending to matters arising in the Liquidation amount to £6,690, made up of 20.3 hours at an average charge out rate of £329.55 per hour. Time is recorded and charged in units of 6 minutes.

In view of the lack of assets realised to date, no remuneration has been drawn.

I attach details of the current charge out rates of myself and my team who have been and will be dealing with the Liquidation.

3. Liquidator's expenses

There have been no payments made from the estate during the period of this progress report apart from those statutory payments made to the Insolvency Service which are shown on the attached receipts and payments account. I have paid £85.20 for statutory advertising and £20 for specific penalty bonding.

It is expected that these costs will be paid in full from the estate only if sufficient realisations are made. The asset realisation of £1,600 refers to the deposit on the HMRC petition.

A statement with regard to my disbursements recovery policy is attached.

4. Liquidator's progress during the period of this report

From the information provided by the director to the Official Receiver, the Company had no assets. The Company ceased trading when it was wound up by the court on 10 July 2017. My investigation into the possibility of uncovering any assets, is ongoing.

The costs of the petitioning creditor have been agreed at £2,270 however, there are insufficient funds to settle these at this stage. These costs will be agreed and paid once there have been sufficient realisations to enable me to do so, and they will be paid in priority to my own costs and expenses.

Specific tasks have been allocated to team members who have specialist knowledge in the relevant areas. I have complied with obligations imposed by statute and my regulatory body which include, but are not limited to, the submission of returns to Companies House and specific penalty bonding.

5. Abstract of the Liquidator's receipts and payments

I attach an abstract of my receipts and payments for the period of this report.

6. Assets which remain to be realised

I have not been made aware of any assets however my enquiries are continuing in this respect.

7. Return to creditors pursuant to Section 176A

The provisions of Section 176A of the Insolvency Act 1986 require a calculation to be made of the prescribed part of the company's net property for distribution to unsecured creditors. The prescribed part must be calculated and provided for where debentures of the company have been created after 15th September 2003.

The prescribed part is calculated as 50% of the first £10,000 of floating charge realisations plus 20% of all other floating charge realisations, subject to a maximum prescribed part of £600,000.

As there are no relevant floating charges or any assets at this stage, the provisions of Section 176A do not apply in this matter.

8. Outcome for creditors

Claims received to date total £325,819 which include a VAT integrated claim from HMRC for £164,309, and a claim from the director of £42,000.

There are presently insufficient funds to enable a dividend to be paid to any class of creditor.

The amount and timing of any dividend will ultimately depend on any recovery from my investigation into the affairs of the company, as detailed above. As such I am unable at present to provide an estimate of any dividend the unsecured creditors may receive.

9. Creditors' right to information

You are reminded that, under Rule 4.49E of the Rules, you may make a request for further information regarding my remuneration and expenses. Any such request must be in writing and should be made within 21 days of receipt of this report. Where the request is made by an unsecured creditor, it must be supported by at least 5% in value of the unsecured creditors.

If the information requested is either prejudicial to my conduct of this case, might lead to violence against any person, may be confidential or the costs of preparing the requested information would be excessive, I may not be obliged to provide it.

I would also remind you that you may make an application to the Court under Rule 4.131 of the Rules in respect of any information provided following such a request, or my failure to provide same, after 14 days of my receipt of that request.

The application to Court must be supported by at least 10% in value of the creditors, including the applicants claim, and notice of the hearing must be given to me 14 days before the hearing. The costs of the application must also be paid the creditors making the application.

Copies of the relevant Rules are also attached for your ease of reference.

Privacy and Data Protection

As part of my role as Liquidator, I would advise you that I may need to access and use data relating to individuals. In doing so, I must abide by data protection requirements. To the extent that you hold any personal data of the Company's data subjects provided to you by the Company or obtained otherwise, you must process such data in accordance with data protection legislation. 10. Next report

I am required to provide a further progress report within two months of the end of the next anniversary of the Liquidation or on the closure of the case, whichever is the sooner.


