**BEFORE DISTRICT JUDGE GOLDBERG ON 18 OCTOBER 2021**

**UPON THE APPLICATION** for a block transfer order pursuant to Rule 12.36 of the Insolvency (England and Wales) Rules 2016

**AND UPON READING** the witness statement of the Applicant and the witness statements of the Respondents consenting to the Application

**AND UPON READING** the Skeleton Argument filed on behalf of the Applicant

**AND UPON READING** an email from the Insolvency Service dated 4 October 2021 confirming that neither the Secretary of State nor the Official Receiver object to the Application

**IT IS ORDERED THAT: -**

1. In respect of those Bankruptcies, Individual Voluntary Arrangements ("IVAs"), Administrations, Company Voluntary Arrangements ("CVAs"), Compulsory Liquidations, Creditors' Voluntary Liquidations ("CVLs") and Members' Voluntary Liquidations ("MVLs") listed in Schedules 1 to 7 attached to this application ("the Schedules") which are the subject of proceedings in the County Court or High Court, those proceedings be transferred to the Business and Property Courts in Leeds, solely for the purpose of hearing the application for the Orders contained in paragraphs 2 to 9 below.
2. The Applicant be removed from office of the estates of the individuals, including Trustee and Supervisor of IVAs for which she is the Joint Appointee listed in Schedules 1 and 2 which will be transferred to the relevant Respondent shown in the Schedules with immediate effect who is to act alongside the existing Joint Appointee with authority to act jointly and severally.
3. The Applicant be removed from office of the estates of the companies, including Supervisor of CVAs, Administrator and Liquidator (both Compulsory and Voluntary) for which she is the Joint Appointee listed in schedule 3 to 7 which will be transferred to the relevant Respondent shown in the Schedules with immediate effect who is to act alongside the existing Joint Appointee with authority to act jointly and severally.

4. The Applicant be replaced as such office holder in the case of each such estate by the Respondents named in the Schedules as her proposed replacement, these replacements to take effect within the timescales referred to at paragraphs 2 to 3 above.
5. In respect of the Administrations listed in Schedule 3, the relevant Respondent named in the Schedule as the Applicant's proposed replacement shall have full power and ability to take an appointment as Liquidator pursuant to paragraph 83 of Schedule B1 to the Insolvency Act 1986 (whether solely or jointly), subject to the other provisions of that paragraph.
6. The Respondents shall be entitled to: -
  - 6.1 Publish in the Gazette one composite notice relating to all new appointments which are required by law to be published in the Gazette; and
  - 6.2 Charge to each individual estate the costs of obtaining an Insolvency Practitioner's licence bond in respect of that estate.
7. The Applicant shall be granted her release as appropriate 7 days after the publication of the notice in the Gazette referred to at paragraph 6.1 above.
8. Pursuant to Rule 12.38(6)(b) of the Insolvency (England and Wales) Rules 2016 and with a view to avoiding unnecessary additional expenses to any of the said estates, the Respondents shall only be required to deliver notice to creditors of the making of this Order when the next routine report is due to the creditors of each estate. Such notice shall contain express reference to the liberty to apply in paragraph 9 below.
9. Liberty to each creditor of each estate to apply to vary or discharge this Order within 7 days of receipt of the notices directed to be sent under paragraph 8 above.
10. An Order that following the Orders made in paragraphs 2 to 9 above, the Bankruptcies, IVAs, CVAs, Administrations, Compulsory Liquidations, CVLs and MVLs referred to in the Schedules be transferred back to the Court or hearing centre from which they were transferred.
11. Service of the said Application Notice be dispensed with.
