Ages of the participants ranged from the under 5 to 100 years old this included a local dementia drop in and the participants from Marple wellbeing project.

Now on permanent outdoor display it attracts much admiration. It has enhanced the surroundings and given local people something to be really proud of being part of. The project has been shortlisted for a National Award to be announced in September, the mayor of Stockport unveiled the mural in November 2018 to a large crowd. From the success of these projects we are being approached by other community groups to help them for fill more collaborative creative community projects.
