



ORDER

UPON THE APPLICATION of the Applicants dated 20 July 2022

AND UPON READING the evidence

IT IS ORDERED THAT:

1. The First Applicant, John Edmund Paylor ('Outgoing Officeholder') be removed from office in respect of each of the cases listed in Schedules A and B (attached to this order) ('Block Transfer Cases') from the date of this order.
2. The First Respondent, Simon Matthew Gwinnutt ('Replacement Officeholder') be appointed as joint replacement office holder in respect of the Block Transfer Cases.
3. The Second Applicant, Sajid Sattar, in his capacity as joint administrator of DSX Global (UK) Limited (in administration) ('DSX') ('Outgoing Administrator') be removed from office in respect of DSX and the First Applicant/Outgoing Officeholder remain as sole administrator.
4. In respect of DSX, any requirement for service of this application on the appointor and the creditors committee, be hereby dispensed with.
5. The creditors in each of the Block Transfer Cases and in the case of DSX, the creditors and the appointor, be notified of this order by one advertisement in the London Gazette relating to the Block Transfer Cases and DSX, within 14 days of the Outgoing Officeholder's and the Outgoing Administrator's solicitors receiving a sealed order of this order. The creditors and appointor, in the case of DSX, shall also be informed of the change in officeholder within the next progress report.
6. Any creditor or, in the case of any members' voluntary liquidation, any member, in respect of any of the Block Transfer Cases or in the case of DSX, the appointor or any creditor, who has an objection to this order shall have 28 days from the date of the notice in the London Gazette to apply to court to set aside or vary the terms of this order. Such application shall not affect the transfer of the Block Transfer Cases and the removal of the Outgoing Administrator in respect of DSX, until further or other order by the court.
7. The Replacement Officeholder shall give notice to the Secretary of State, the Registrar of Companies in respect of the Block Transfer Cases, of the terms of this order as soon as reasonably practicable.
8. The Outgoing Officeholder shall give notice to the Secretary of State, the Registrar of Companies in respect of the case of DSX, of the terms of this order as soon as reasonably practicable.

9. The Outgoing Officeholder shall receive his release as liquidator of the Block Transfer Cases, 28 days after the giving of notice to creditors in the London Gazette accordance with paragraph 5 of this order, save that such release may be subject to further order in the event of an application by any creditor or member under paragraph 6 of this order for the specific case subject to that application.
10. The Outgoing Administrator shall receive his release as administrator of DSX 28 days after the giving of notice to creditors in the London Gazette in accordance with paragraph 5 of this order, save that such release may be subject to further order in the event of an application by any creditor of DSX under paragraph 6.
11. The costs of this application shall be paid as an expense of and by Greenfield Recovery Ltd.
12. This order has been made by the Court under CPR 23.9, as the court has disposed of an application without hearing and without service. Any party may apply to have this order set aside or varied within 7 days of the date of service of this order on that party.
