- The First Applicant, John Edmund Paylor ('Outgoing Officeholder') be removed from office in respect of each of the cases listed in Schedules A and B (attached to this order) ('Block Transfer Cases') from the date of this order.
- 2. The First Respondent, Simon Matthew Gwinnutt ('Replacement Officeholder') be appointed as joint replacement office holder in respect of the Block Transfer Cases.
- 3. The Second Applicant, Sajid Sattar, in his capacity as joint administrator of DSX Global (UK) Limited (in administration) ('DSX') ('Outgoing Administrator') be removed from office in respect of DSX and the First Applicant/Outgoing Officeholder remain as sole administrator.
- 4. In respect of DSX, any requirement for service of this application on the appointor and the creditors committee, be hereby dispensed with.
- 5.
