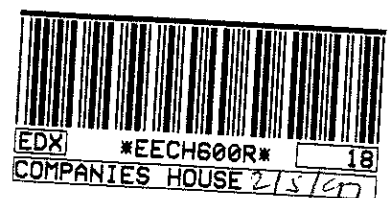

NOTES
