

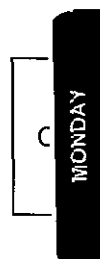

**UPON** reading the Ordinary Application dated 9<sup>th</sup> November 2015,

**AND UPON** reading the affidavits of:

1. Melanie Reevel Giles sworn on 3<sup>rd</sup> November 2015;
2. Neil Robert Adair sworn on 6<sup>th</sup> November 2015; and
3. Wilfred Vaughan Jones sworn on 3<sup>rd</sup> November 2015.

**AND UPON IT APPEARING** that all matters comprising the subject of this block transfer application are in the jurisdiction of the High Court of Justice in Northern Ireland

**IT IS ORDERED THAT**

1. Neil Robert Adair and/or Wilfred Vaughan Jones be removed from office as Administrator, Liquidator, Trustee and/or Supervisor (as the case may be) of the estates listed in Schedule A-E hereto with immediate effect.
2. Neil Robert Adair and/or Wilfred Vaughan Jones be replaced either solely or jointly by the First Applicant in the case of each such estate as the case may be named in the said Schedules A-E as the proposed replacement with immediate effect.
3. In the case in Schedule D (Geotech Construction Limited (in administration)) where Wilfred Vaughan Jones is removed as joint administrator, the remaining Officer Holder, Neil Robert Adair shall be the sole nominated administrator under the terms of the administration.
4. Neil Robert Adair and Wilfred Vaughan Jones shall be granted their respective releases as appropriate 21 days after the publication in the Belfast Gazette ('The Gazette') referred to below.
5. The First Applicant shall be entitled to publish in The Gazette one composite notice relating to all new appointments which are required by law to be published in The Gazette within 14 days of receipt of the sealed Order and shall file any appropriate notices in respect of the removal of Neil Robert Adair and/or Wilfred Vaughan Jones and the appointment of replacement Office Holders and those appointments with the Registrar of Companies and the Department of Enterprise, Trade and Industry (Insolvency Services) as appropriate.
6. Notice in writing of this Order shall also be given to the creditors in each case at the first convenient opportunity to do so without incurring additional expense (save that the First Applicant may incur the expense of notifying creditors if it appears to her to be necessary to do so in a particular case).
7. The costs of this placing notice of this Order in The Gazette and the costs of this Application shall be aggregated and be drawn as a proper expense of each of the cases listed in the Schedules which shall each bear an equal proportion of such costs and disbursements where sufficient funds are available.
8. If in any of the cases listed in the Schedules there are insufficient funds to bear that case's

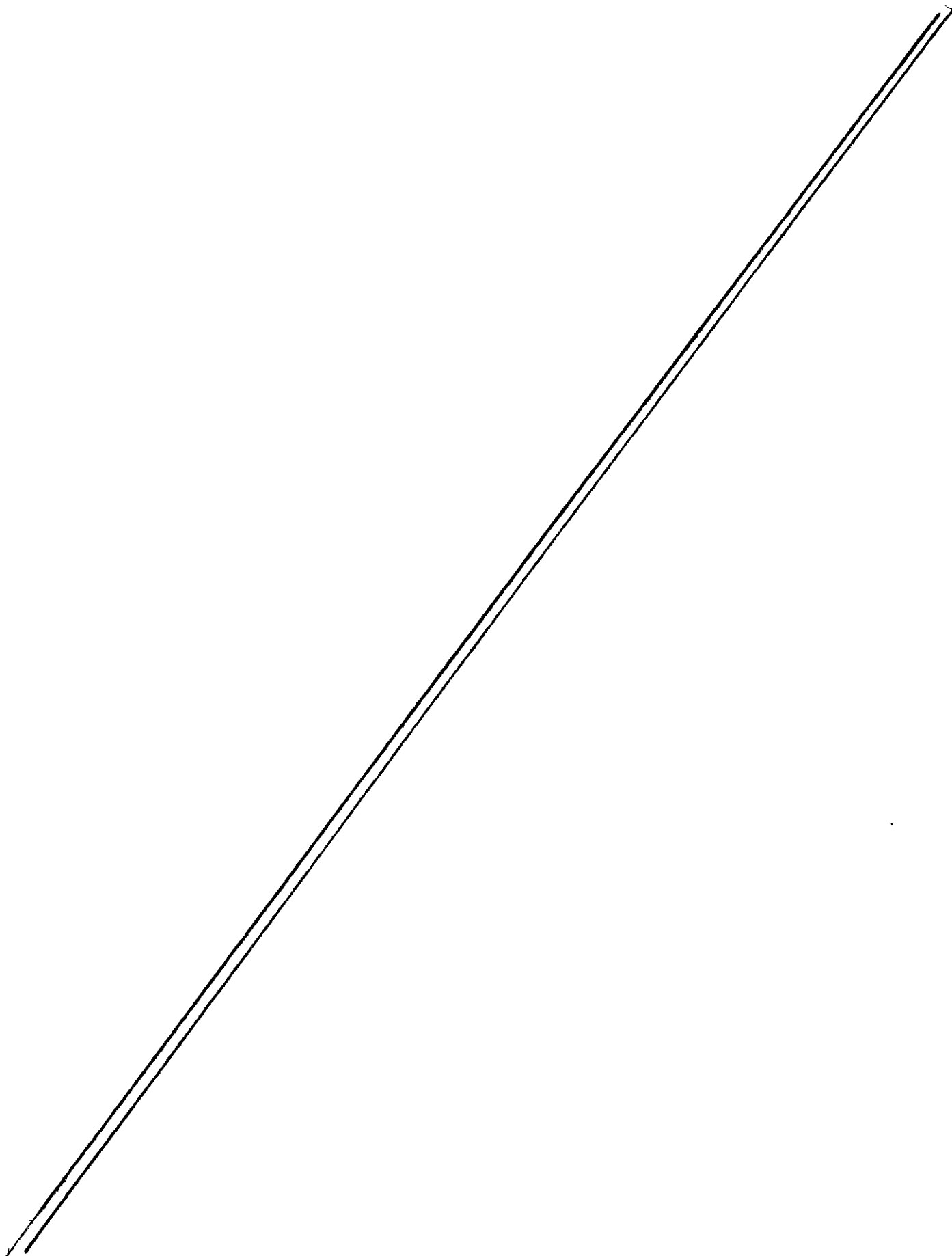

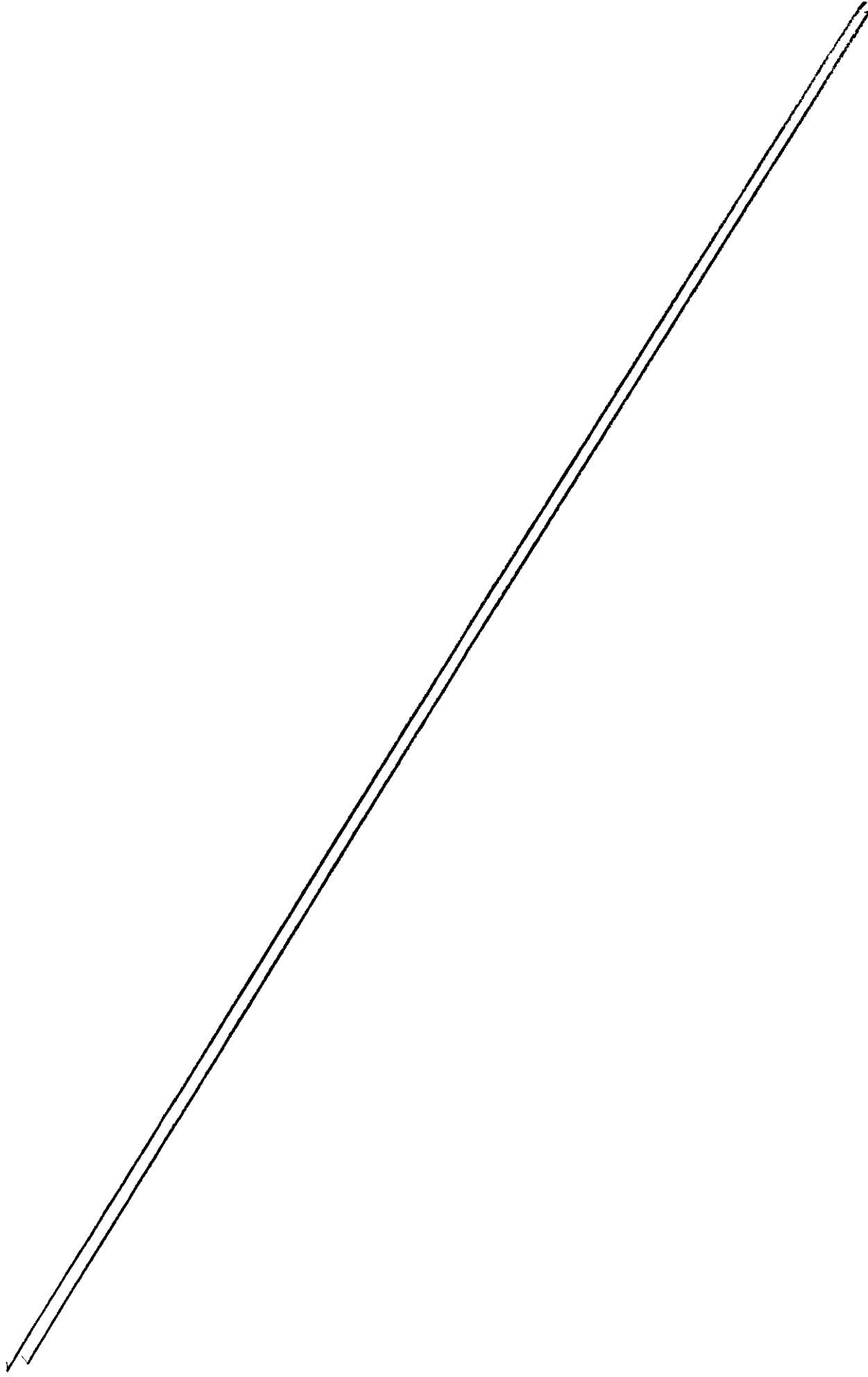
