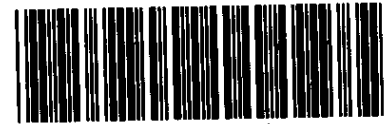

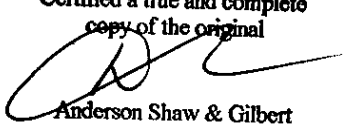

1 Obligations

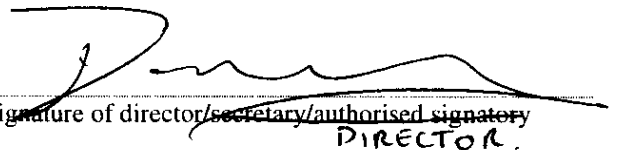
