The Sheriff, having resumed consideration of the foregoing petition together with the productions produced, and having seen the extract from the Edinburgh Gazette dated 13 September 2019 and the Aberdeen Press and Journal newspaper dated 14 September 2019 each containing the intimation ordered by the preceding interlocutor, no answers to said petition having been lodged in court, Finds (1) that the amount of the share capital of Leip-Air Services Limited, (Company No. SC491087) a Company incorporated under the Companies Act and having its Registered Office at 24 Ellon Road, Bridge of Don, Aberdeen AB23 8BX, paid up or credited as paid up does not exceed £120,000; and (2) that the said company is unable to pay its debts; therefore Orders that the said company be wound up in pursuance of the Insolvency Act, 1986, Nominates and Appoints Colin Anthony Fisher Hastings, 82 Mitchell Street, Glasgow G1 3NA to be the interim liquidator of the said company with the usual powers, all in terms of said Statute and of Law; Finds the petitioner entitled to the expenses of this application and Directs same to be expenses in the liquidation.
