

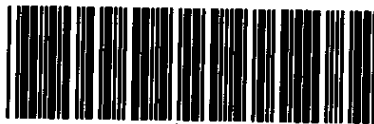

The sheriff, having resumed consideration of the foregoing petition together with the productions produced, and having seen the Edinburgh Gazette dated 31 January 2020 and the Courier newspaper dated 31 January 2020 each containing the intimation ordered by the preceding interlocutor, no answers to said petition having been lodged in court, Finds (1) that the amount of the share capital of the said Newth Hospitality Limited paid up or credited as paid up does not exceed £120,000; (2) that the said company is unable to pay its debts;

therefore Orders that the said company, having its registered office at 11 Dudhope Terrace, Dundee, Scotland, DD3 6TS be wound up in pursuance of the Insolvency Act, 1986; Nominates and Appoints Christine Convy, Insolvency Practitioner and Chartered Accountant of Dunedin Advisory, H5 Newark Business Park, Newark Road South, Glenrothes, Fife KY7 4NS to be the interim liquidator of the said company with the usual powers, all in terms of said Statute and of Law; Finds the petitioner entitled to the expenses of this application as taxed; Allows an account thereof to be given and allows the same to be lodged to the auditor of court to tax and report. and Directs same to be expenses in the liquidation.
